

ORDINANCE NO. 261

AN ORDINANCE ANNEXING TO THE CITY OF MESQUITE,
TEXAS, CERTAIN TERRITORY OR TRACT OF LAND IN
DALLAS COUNTY, TEXAS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS,
AS FOLLOWS:

THAT one certain territory or tract of land situated in Dallas County, Texas, be and it is hereby annexed to the City of Mesquite, Texas, said territory or tract of land being particularly described by metes and bounds as follows, to wit:

BEGINNING at a point in the present corporate limit lines of the City of Mesquite, said point being in the North line of Lake June Road, as defined in City of Mesquite, Texas, Ordinance No. 244, and said point being the point of intersection of the said Lake June Road North line and a projection of the West survey line of the W. C. Lundy Survey, Abstract No. 420, Dallas County, Texas;

THENCE South along the West survey line of the W. C. Lundy Survey, Abstract No. 420, and said survey line projected to a point in the center line of Pioneer Road, said point being in the southerly line of the B. Beckner Survey, Abstract No. 167, Dallas County, Texas;

THENCE South 45 degrees West along the southerly line of the said B. Beckner Survey, Abstract No. 167, being the center line of Pioneer Road to the center line of South Mesquite Creek;

THENCE Northerly with the meanderings of South Mesquite Creek along the center line of South Mesquite Creek to the intersection of the center line of said South Mesquite Creek and the southerly right-of-way line of Lake June Road, also called Belt Line Road;

THENCE Northeasterly along the South line of Lake June Road to a point opposite the point of intersection of the North line of the James Moore Survey, Abstract No. 972, Dallas County, Texas, and the West survey line of the E. Barroux Survey, Abstract No. 161, Dallas County, Texas;

THENCE North along the West line of the said E. Barroux Survey, Abstract No. 161, projected and the West line of the said Survey 161 to a point in the North right-of-way line of Lake June Road, said point being the Southwest corner of a tract of land deeded to Harry Sellers and recorded in Volume 2317, Page 340, Dallas County, Texas Deed Records, and being a corner of the corporate limits of the City of Mesquite, Texas, as defined in the City of Mesquite, Texas, Ordinance No. 244;

THENCE Easterly along the North line of Lake June Road, being the corporate limit line of the City of Mesquite to the place of beginning.
