

ORDINANCE NO. 400

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS PROHIBITING THE PARKING OF ANY VEHICLE AT ANY TIME ON CERTAIN STREETS WITHIN THE CORPORATE LIMITS OF THE CITY OF MESQUITE WHEN SIGNS ARE ERECTED OR CURBS MARKED GIVING NOTICE THEREOF; PROHIBITING THE PARKING OF ANY VEHICLE BETWEEN CERTAIN HOURS ON CERTAIN DAYS ON CERTAIN STREETS WITHIN THE CORPORATE LIMITS OF THE CITY OF MESQUITE WHEN SIGNS ARE ERECTED OR CURBS MARKED GIVING NOTICE THEREOF; PROVIDING THAT THE CITY MANAGER SHALL BE AUTHORIZED TO ORDER THE ERECTION OF APPROPRIATE SIGNS AND MARK CURBS GIVING NOTICE THEREOF; PROVIDING FOR PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

Section 1. When signs are erected or curbs marked giving notice thereof, no person, firm or corporation shall park a vehicle at any time upon any of the streets, or portions thereof, described as follows, to-wit:

1. South side of Tam O'Shanter Drive from the East side of Gus Thomasson Road to a point 240 feet East and on Gus Thomasson Road from the South side of Tam O'Shanter Drive to a point 36 feet South.
2. West side of Gus Thomasson Road from the North side of Antilles Drive (extended) South to the North side of Caribbean Drive (extended).
3. South side of LaPrada Drive from the West property line of the Church property to a point 240 feet East.
4. Both sides of Sarazen Drive from Oates Drive to the South side of Maple Drive.
5. South side of Oates Drive from the West side of Dumont Drive (extended) to the East side of Hyde Park Drive.
6. East side of Gus Thomasson Road from the South right-of-way line of Tripp Road to a point 200 feet South.
7. East side of Gus Thomasson Road from the South side of Ridgeview Street (extended) to a point 300 feet South.

8. West side of Gross Road from the alley in Block M of Big Town Estates Addition No. 4 to a point 200 feet South.
9. North side of Mimosa Lane from the West right-of-way line of Belt Line Road to a point 200 feet West.
10. North side of W. Kimbrough Street from the West right-of-way line of Lawrence Street to a point 140 feet West.
11. East side of North Galloway from the North side of W. McKinney Street (extended) to the North side of Kimbrough Street and on the North side of E. Kimbrough Street from the East side of N. Galloway Avenue East to the East side of Bryan Street right-of-way and on the East side of N. Seaton from East Texas Street to E. Kimbrough Street and on the South side of E. Kimbrough Street from the East side of N. Seaton Street to the East line of Bryan Street right-of-way.
12. North side of College Street from the East right-of-way line of S. Locust Street to a point 130 feet East and the South side of College Street from the West right-of-way line of S. Ebrite Street to a point 140 feet West.
13. East side of S. Ebrite Street from the South side of W. Gross Street to the North side of W. Holley Street.
14. West side of S. Walker Street from the North side of W. Holley Street (extended) to a point 200 feet South.
15. East side of Hickory Tree Road from the South right-of-way line of New Market Road to a point 218 feet South.
16. South side of Agnew Street from the East right-of-way line of Rupard Street to the West right-of-way line of Wilkinson Drive.
17. East side of South Galloway Avenue from the South right-of-way line of Paza Drive to a point 884 feet South.
18. South side of Scyene Road from the West right-of-way line of Fleet Circle to a point 100 feet West and the West side of Fleet Circle from the South right-of-way line of Scyene Road to a point 435 feet South.
19. South side of Scyene Road along the Church property of Gospel Tabernacle 110 feet.

20. North side of Military Parkway starting at a point 1230 feet West of Lindsey Street thence to a point 100 feet West.
21. East side of Gus Thomasson Road from the Northwesterly to the Southeasterly property line of the Macedonia Baptist Church, said distance being 100 feet.
22. North side of Haddock Drive starting at a point 234 feet East of the East right-of-way line of Peachtree Road thence to a point 166 feet East.
23. South side of Mimosa Lane from the West property line of the property of Mimosa Lane Baptist Church to a point 225 feet East.
24. East side of Gus Thomasson Road from the North right-of-way line of U.S. Highway 80 to a point 77 feet Northwesterly.
25. East side of Pioneer Road from the alley in Block A of Highland Hills Addition to a point 226 feet North.
26. West side of South Galloway Avenue starting at a point 498 feet South of the South right-of-way line of Borchardt Drive thence to a point 300 feet South.
27. East side of South Galloway Avenue from the North side of the cemetery to a point 275 feet North.
28. South side of Newsom Street from the East right-of-way line of Pioneer Road to a point 193 feet East.
29. East side of North Galloway Avenue and South Galloway Avenue from the South side of E. Kimbrough Street to the North side of Gross Street, thence on Gross Street from the East side of South Galloway Avenue to the West side of Florence Street and the West side of Carver Street from Gross Street to Davis Street and the West side of South Galloway Avenue from College Street to Texas Street.

Section 2. When signs are erected or curbs marked giving notice thereof, no person, firm or corporation shall park a vehicle between the hours of 7:00 o'clock A.M. to 6:00 o'clock P.M., Mondays through Saturdays, inclusive, upon any of the streets, or portions thereof, described as follows, to-wit:

West side of Rugel Street from College Street to Davis Street,


East side of Gibson Street from College Street to Davis Street.

Section 3. It shall be the duty of the City Manager, or other person designated by him, to erect appropriate signs or mark curbs giving notice of the no-parking regulations described above and no such regulations shall be effective unless signs are marked or in place at the time of an alleged offense.


Section 4. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction in the Corporation Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

Section 5. Whereas the parking regulations in certain areas in the City of Mesquite are inadequate to regulate and control the parking of vehicles, creates an urgency and emergency and in the preservation of public business, health, safety and welfare requires that this ordinance shall take effect immediately after its passage and the publication of the caption sheet, as the law and charter in such cases provides.
