

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, REPEALING ORDINANCE NO. 341 HERETOFORE PASSED ON NOVEMBER 21, 1960, AND REPEALING SECTION 10-61.1 OF CHAPTER 10 OF THE MESQUITE CITY CODE OF 1960, WHICH SAID ORDINANCE AND SECTION OF THE CITY CODE HERETOFORE PROVIDED THAT IT BE UNLAWFUL FOR THE DRIVER OR OWNER OF ANY VEHICLE TO STOP, STAND OR PARK SUCH VEHICLE BETWEEN THE HOURS OF 8 A. M. AND 6 P. M. EXCEPT SUNDAYS AND LEGAL HOLIDAYS, FOR A PERIOD OF LONGER THAN ONE HUNDRED TWENTY (120) MINUTES ON THE FOLLOWING STREETS: BRYAN STREET, WESTSIDE BETWEEN MAIN STREET AND DAVIS STREET; CITY SQUARE, ALL PARKING AREAS LOCATED IN AREA KNOWN AND DESIGNATED AS THE CITY SQUARE; DAVIS STREET, NORTH AND SOUTH SIDES, BETWEEN WALKER STREET AND BRYAN STREET; EBRITE STREET, EAST AND WEST SIDES, BETWEEN MAIN STREET AND DAVIS STREETS; LANCASTER STREET, EAST AND WEST SIDES, BETWEEN MAIN STREET AND DAVIS STREET; LOCUST STREET, EAST AND WEST SIDES, BETWEEN MAIN STREET AND DAVIS STREET; MAIN STREET, NORTH AND SOUTH SIDES BETWEEN WALKER STREET AND BRYAN STREET AND WALKER STREET, EAST SIDE, BETWEEN MAIN STREET AND DAVIS STREET; AND PROVIDING THAT THE PROVISIONS OF SAID ORDINANCE AND SECTION OF SAID CODE SHALL NO LONGER BE OF ANY FORCE AND EFFECT; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1: That City of Mesquite Ordinance No. 341, duly passed on November 21, 1960, and Section 10-61.1 of Chapter 10 of the Mesquite City Code of 1960 is hereby repealed and from and after the passage of this ordinance shall have no further force or effect.

SECTION 2: That said Ordinance and Section of the Mesquite City Code which is hereby repealed prohibited the parking of any vehicle between the hours of 8 A. M. and 6 P. M. except Sundays and legal holidays, for a period of longer than one hundred twenty (120) minutes upon the streets described as follows: Bryan Street, west side, between Main Street and Davis Street; City Square, all parking areas located in area known and designated as the City Square; Davis Street, north and south sides, between Walker Street and Bryan Street; Ebrite Street, east and west sides, between Main Street and Davis Street; Lancaster Street, east and west sides, between Main Street and Davis Street; Locust Street, east and west sides, between Main Street and Davis Streets; Main Street, north and south sides between Walker Street and Bryan Street and Walker Street, east side, between Main Street and Davis Street.

SECTION 3: The fact that the parking regulations as established by Ordinance No. 341 and Section 10-61.1 of

Chapter 10 of the Mesquite City Code of 1960, are no longer necessary for the proper regulation of parked or moving traffic in the areas covered by said Ordinance and Section and as set forth therein, creates an urgency and an emergency and makes it necessary that same be repealed and in the preservations of the health, safety and welfare requires that this ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law and Charter in such cases provides.
