

ORDINANCE NO. 613

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THE MESQUITE CITY CODE OF 1960 BY AMENDING SECTION 10-61.2 SO AS TO PROHIBIT THE PARKING OF ANY VEHICLE AT ANY TIME WHEN SIGNS ARE ERECTED OR CURBS MARKED GIVING NOTICE THEREOF ON THE NORTH AND SOUTH SIDES OF GROSS STREET FROM SOUTH GALLOWAY AVENUE EAST TO BRYAN STREET; ON THE SOUTH SIDE OF GRUBB STREET FROM GUS THOMASSON ROAD WEST TO A POINT 507 FEET WEST OF THE WEST CURB LINE OF EBRITE STREET AND GRUBB DRIVE; ON THE SOUTH SIDE OF HILLCREST STREET FROM A POINT 270 FEET WEST OF THE WEST CURB LINE OF LEE STREET AND HILLCREST STREET, WEST TO A POINT 1,075 FEET WEST OF THE WEST CURB LINE OF LEE STREET AND HILLCREST STREET; ALSO AMENDING SECTION 10-47.8 OF THE MESQUITE CITY CODE OF 1960 SO AS TO REGULATE THE SPEED OF MOTOR VEHICLES ON TOWN EAST BOULEVARD FROM U. S. HIGHWAY 80 SOUTH TO MILITARY PARKWAY; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1: That Section 10-61.2 of Article VI, Chapter 10 of the Mesquite City Code of 1960 be, and the same is hereby amended by adding thereto the following:

"Section 10-61.2. Parking at any time prohibited on Certain designated streets.

When signs are erected or curbs marked giving notice thereof, no person shall park a vehicle at any time upon any of the streets, or portions thereof, described as follows:

Gross Street, North and South sides, from South Galloway Avenue east to Bryan Street.

Grubb Drive, South side, from Gus Thomasson Road west to a point 507 feet west of the west curb line of Ebrite Street and Grubb Drive.

Hillcrest Street, South side, from a point 270 feet west of the west curb line of Lee Street and Hillcrest Street, west to a point 1,075 feet west of the west curb line of Lee Street and Hillcrest Street.

SECTION 2: That all other provisions of Section 10-61.2 of the Mesquite City Code of 1960 shall remain in full force and effect.

SECTION 3: That Chapter 10, Article V, Section 10-47.8 of the Mesquite City Code of 1960 is hereby amended by adding thereto the following so as to hereafter read as follows:

"Section 10-47.8. Speed Restrictions.

No person shall operate or drive a motor or other vehicle on the following designated streets at a greater speed than the speed designated for that street or portion of that street as set forth below in this section and any speed in excess of the limit set forth in this section shall be prima facie evidence that such speed is neither reasonable nor prudent and is unlawful.

Street	Extent	Speed (MPH)
Towneast Boulevard	U.S. Highway #80 south to Military Parkway	40

SECTION 4: All other provisions of Chapter 10, Article V, Section 10-47.8 shall remain in full force and effect.

SECTION 5: That any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction in corporation court shall be subject to a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 6: The fact that the present ordinances of the City of Mesquite do not adequately regulate the parking of vehicles on portions of Gross Street, Grubb Drive and Hillcrest Street above described, and that the present ordinances do not adequately regulate the speed of motor vehicles on that portion of Towneast Boulevard above described, creates an urgency and an emergency and in the preservation of the public health, safety and welfare requires that this ordinance shall take effect immediately from and after its passage and the publication of the caption as the law and charter in such cases provides.
