AN ORDINANCE OF THE CITY OF MESCUITE, TEXAS, AMENDING THE COM-PREHENSIVE ZONING ORDINANCE OF 1964, DULY PASSED BY THE CITY COUNCIL ON AUGUST 17, 1964, SO AS TO GIVE THE FOLLOWING DESCRIBED PROPERTY A SPECIAL PERMIT FOR A NURSING HOME, SAID PROPERTY BE-ING IN THE CITY OF MESCUITE, DALLAS COUNTY, TEXAS, AND DESCRIBED AS FOLLOWS: BEING A TRACT OF LAND SITUATED IN THE DANIEL TANNER SURVEY ABSTRACT NO. 1462, CITY OF MESQUITE, DALLAS COUNTY, TEXAS, AND BEING PART OF A 39. 207 ACRE TRACT CONVEYED TO J. TO A POINT FOR CORNER; THENCE SOUTH 28 DEGREES 30 MIN-UTES WEST WITH AN EASTERLY LINE OF SAID 39. 207 ACRE TRACT, 137. 77 FT.
