AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMEND-ING SECTION 10-61.2 OF ARTICLE VI. "PARKING AT ANY TIME PROHIBITED ON CERTAIN DESIGNATED STREETS. " OF THE CITY CODE OF THE CITY OF MESQUITE: BY REPEALING THOSE PROVISIONS OF SAID SECTION PROHIBITING PARKING AT THE FOLLOWING LOCATIONS; TO WIT: NORTH GALLOWAY AVENUE AND SOUTH GALLOWAY AVENUE, EAST SIDE, FROM THE SOUTH SIDE OF EAST KIMBROUGH STREET TO THE NORTH SIDE OF GROSS STREET; THENCE ON GROSS STREET FROM THE EAST SIDE OF SOUTH GALLOWAY AVENUE TO THE WEST SIDE OF FLORENCE STREET AND THE WEST SIDE OF CARVER STREET FROM GROSS'STREET TO DAVIS STREET AND THE WEST SIDE OF SOUTH GALLOWAY AVENUE FROM COLLEGE STREET TO TEXAS STREET; SOUTH GALLOWAY AVENUE, EAST SIDE, FROM THE SOUTH RIGHT-OF-WAY LINE OF PAZA DRIVE TO A POINT EIGHT HUNDRED EIGHTY-FOUR FEET SOUTH; SOUTH GALLOWAY AVENUE, WEST SIDE, START-ING AT A POINT FOUR HUNDRED AND NINETY-EIGHT FEET. SOUTH OF THE SOUTH RIGHT-OF-WAY LINE OF BORCHARDT DRIVE; THENCE TO A POINT THREE HUNDRED FEET SOUTH, SOUTH GALLOWAY AVENUE, EAST AND WEST SIDES, FROM GROSS STREET TO HOLLEY STREET; BY PROHIBITING PARK-ING AT THE FOLLOWING LOCATIONS; TO WIT: GROSS STREET. BOTH SIDES FROM THE EAST SIDE OF SOUTH GALLOWAY AVENUE TO THE WEST SIDE OF FLORENCE STREET AND THE WEST SIDE OF CARVER STREET FROM GROSS STREET TO DAVIS STREET AND THE WEST SIDE OF SOUTH GALLOWAY AVENUE FROM COLLEGE STREET TO TEXAS STREET; SOUTH GALLOWAY AVENUE, EAST AND WEST SIDES. FROM THE TEXAS AND PACIFIC RAILROAD TO THE SOUTH LINE OF NEW MARKET STREET; BY RETAINING IN FULL FORCE AND EFFECT ALL PROVISIONS OF ARTICLE VI, SECTION 10-61.2 OF THE CITY CODE OF MESQUITE NOT SPECIFICALLY REPEALED BY THIS ORDINANCE; BY PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That those provisions of Article VI, Section 10-61.2 of the City of Mesquite, prohibiting parking at the hereinafter named locations shall be, and the same are, hereby repealed, to wit:

"North Galloway Avenue and South Galloway Avenue, east side, from the south side of East Kimrough Street to the north side

of Gross Street; thence on Gross Street from the east side of South Galloway Avenue to the west side of Florence Street and the west side of Carver Street from Gross Street to Davis Street and the west side of South Galloway Avenue from College Street to Texas Street;"

"South Galloway Avenue, east side, from the south right-ofway line of Paza Drive to a point eight hundred eighty-four feet south;"

"South Galloway Avenue, west side, starting at a point four hundred ninety-eight feet south of the south right-of-way line of Borchardt Drive; thence to a point three hundred feet south;"

"South Galloway Avenue, east and west sides, from Gross Street to Holley Street."

SECTION 2. That parking at any time shall be prohibited at the following locations, under the requisites set forth in Article VI, Section 10-61.2, to wit:

"Gross Street, both sides, from the east side of South Galloway Avenue to the west side of Florence Street and the west side of Carver Street from Gross Street to Davis Street and the west side of South Galloway Avenue from College Street to Texas Street;"

"South Galloway Avenue, east and west sides, from the Texas and Pacific Railroad to the south line of New Market Street."

SECTION 3. That all provisions of Article VI, Section 10-61.2 of the City Code of the City of Mesquite, not specifically repealed by this ordinance, shall remain in full force and effect.

SECTION 4. That it is hereby declared to be the intent of the City Council that the provisions of the ordinance be deemed severable; and in the event any such provision be declared invalid or unconstitutional for any reason, such invalidity or unconstitutionality shall not affect those provisions hereof left standing.

SECTION 5. That the current ordinances of the City of Mesquite are inadequate to regulate parking at the locations named herein constitutes an urgency and emergency in the interest of the public health, safety, and welfare, and necessitates that this ordinance take effect immediately from and after its date of passage.
