AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF 1964. DULY PASSED BY THE CITY COUNCIL ON AUGUST 17, 1964, SO AS TO GRANT A CHANGE OF ZONING ON THE HEREINAFTER DESCRIBED PROPERTY FROM "LR" LOCAL RETAIL DISTRICT TO "A" MULTIPLE-FAMILY DISTRICT, SAID PROPERTY BEING IN THE CITY OF MESQUITE, DALLAS COUNTY, TEXAS, AND DESCRIBED AS FOLLOWS: BEING A TRACT OF LAND SITUATED IN THE J. HARDIN SURVEY, ABSTRACT NO. 545, DALLAS COUNTY, TEXAS, AND BEING OF CASA VIEW HEIGHTS NO. 16, SIXTH SECTION, AND CASA VIEW HEIGHTS NO. 16 SHOPPING CENTER, ADDITIONS TO THE CITY OF MESQUITE, TEXAS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE MOST NORTHERLY NORTH CORNER OF LOT 1, BLOCK 17 OF SAID CASA VIEW HEIGHTS NO. 16, SIXTH SECTION, SAID POINT BEING ON THE SOUTHEASTERLY LINE OF MOON DRIVE, AN IRON STAKE FOR CORNER; THENCE NORTH 33° 44' EAST, 20.38 FEET ALONG SAID SOUTHEASTERLY LINE OF MOON DRIVE TO A POINT ON THE NORTHEASTERLY LINE OF SAID CASA VIEW HEIGHTS NO. 16, SIXTH SECTION, AN IRON STAKE THENCE NORTH 47° 56' EAST, 436.98 FEET ALONG THE SOUTHEASTERLY LINE OF A 50 FOOT POWER LINE EASEMENT AND SAID SOUTHEASTERLY LINE OF MOON DRIVE, AN IRON STAKE THENCE SOUTH 42° 04' EAST, 319.48 FEET TO A FOR CORNER; POINT ON THE SOUTHEASTERLY LINE OF SAID CASA VIEW HEIGHTS NO. 16 SHOPPING CENTER, AN IRON STAKE FOR CORNER; SOUTH 44° 53' WEST, 439.36 FEET ALONG SAID SOUTHEASTERLY LINE OF CASA VIEW HEIGHTS NO. 16 SHOPPING CENTER TO A POINT ON THE SOUTHWESTERLY LINE OF A 20 FOOT EASEMENT IN SAID CASA VIEW HEIGHTS NO. 16, SIXTH SECTION, AN IRON STAKE FOR CORNER; THENCE NORTH 45° 07' WEST, 338.33 FEET ALONG SAID SOUTHWESTERLY LINE OF 20 FOOT EASEMENT TO THE PLACE OF BEGINNING AND CONTAINING 3.41 ACRES OF LAND. in the area, the City of Mesquite is of the opinion that the said change of zoning should be granted herein:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Comprehensive Zoning Ordinance of 1964, duly passed by the City Council of the City of Mesquite, Texas, on the 17th day of August, 1964, be, and the same is, hereby amended by amending the Zoning Map of the City of Mesquite so as to grant a change of zoning on the following described property from "LR" Local Retail to "A" Multiple-Family District, said property being in the City of Mesquite, Dallas County, Texas, and described as follows:

BEING a tract of land situated in the J. Hardin Survey, Abstract No. 545, Dallas County, Texas, and being of Casa View Heights No. 16, Sixth Section, and Casa View Heights No. 16 Shopping Center, additions to the City of Mesquite, Texas, and being more particularly described as follows:

BEGINNING at the most northerly North corner of Lot 1, Block 17 of said Casa View Heights No. 16, Sixth Section, said point being on the Southeasterly line of Moon Drive, an iron stake for corner;

THENCE North 33° 44' East, 20.38 feet along said Southeasterly line of Moon Drive to a point on the Northeasterly line of said Casa View Heights No. 16, Sixth Section, an iron stake for corner;

THENCE North 47° 56' East, 436.98 feet along the Southeasterly line of a 50 foot Power Line Easement and said Southeasterly line of Moon Drive, an iron stake for corner;

THENCE South 42° 04' East, 319.48 feet to a point on the Southeasterly line of said Casa View Heights No. 16 Shopping Center, an iron stake for corner;

THENCE South 44° 53' West, 439.36 feet along said South-easterly line of Casa View Heights No. 16 Shopping Center to a point on the Southwesterly line of a 20 foot easement in said Casa View Heights No. 16, Sixth Section, an iron stake for corner;

THENCE North 45° 07' West, 338.33 feet along said Southwesterly line of 20 foot easement to the place of beginning and containing 3.41 acres of land.

SECTION 2. That all ordinances of the City of Mesquite in conflict with the provisions of this ordinance be, and the same are, hereby repealed, and all other ordinances of the City of Mesquite not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That the above described tract of land shall be used only in the manner and for the purposes provided for by the Comprehensive Zoning Ordinance of 1964.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole, or any part or provision hereof other than the part so decided to be invalid, illegal, or unconstitutional and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

SECTION 5. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1964 of the City of Mesquite, and upon conviction shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 6. Whereas, the above described property requires that it be given the above zoning classification in order to permit its proper development and in order to protect the public interest, comfort, and general welfare of the City of Mesquite, and creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of the caption of said ordinance, as the law in such cases provides.
