ORDINANCE NO. 873

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 10-61.2 OF THE CITY CODE OF THE CITY OF MESQUITE BY PROHIBITING PARKING ON BOTH SIDES OF EXECUTIVE BOULEVARD FROM TOWN EAST BOULEVARD TO SAM HOUSTON ROAD; BOTH SIDES AND THE MEDIAN STRIP OF SKYLINE DRIVE FROM ITS INTERSECTION WITH TOWN EAST BOULEVARD TO ITS MOST EASTERLY POINT; AND FURTHER PROHIBITED ON BOTH SIDES OF TOWN EAST BOULEVARD AND THE MEDIAN STRIP THEREOF FROM SAMUELS BOULEVARD TO MILITARY PARKWAY; BY DIRECTING THE CITY MANAGER TO CAUSE TO BE POSTED ADEQUATE SIGNS TO NOTIFY THE PUBLIC THAT PARKING AT SUCH LOCATION IS PROHIBITED; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING A PENALTY FOR VIOLATION NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Section 10-61.2 of the City Code of the City of Mesquite, Texas, shall be and the same is hereby amended so as to add the following and in all other respects shall remain in full force and effect, to wit:

Upon the posting by appropriate signs parking of vehicles shall be prohibited on both sides of Executive Boulevard from Town East Boulevard to Sam Houston Road, both sides and the median strip of Skyline Drive from its intersection with Town East Boulevard to its most Easterly point, and is further prohibited on both sides of Town East Boulevard and the median strip thereof from Samuels Boulevard to Military Parkway.

SECTION 2. That the City Manager is hereby directed to cause to be posted adequate signs to notify the public that parking at the aforesaid locations is prohibited.

SECTION 3. That it is the intent of the City Council that this ordinance be deemed severable and in the event that any provision hereof shall be declared invalid or unconstitutional for any reason such invalidity or unconstitutionality shall not affect the provisions of this ordinance left standing nor any other ordinances of the City of Mesquite.

SECTION 4. That any person who violates the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be subject to a fine in an amount not to exceed Two Hundred Dollars (\$200.00).

SECTION 5. That the present ordinances of the City of Mesquite being inadequate to properly regulate parking on Executive Boulevard, Skyline Drive from its intersection with Town East Boulevard to its most Easterly point, as it presently exists and as it may be extended, and Town East Boulevard from Samuels Boulevard to Military Parkway, constitutes an urgency and an emergency in the interest of the public health, safety, and welfare, and necessitates that this ordinance take effect immediately from and after its date of passage and publication of its caption as provided by law.
