## ORDINANCE NO. 898

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ADOPTING THE 1970 SUPPLEMENT TO "THE CODE OF THE CITY OF MESQUITE, TEXAS, 1960" PROVIDING FOR A PENALTY OR FINE NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE AND VIOLATION OF SAID SUPPLEMENT TO THE CODE ABOVE.

WHEREAS, "The Code of the City of Mesquite, 1960" has been revised by the 1970 Supplement thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the 1970 Supplement to "The Code of the City of Mesquite, Texas, 1960" is hereby adopted, a copy of which is attached hereto and made a part hereof the same as if copied in full herein.

SECTION 2. Whenever in the Supplement of 1970 to "The Code of the City of Mesquite, Texas, 1960" or in any ordinance of the City, any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor or whenever in such Code or ordinance the doing of any act is required or the failure to do any act is declared to be unlawful, where no specific penalty is provided therefor, the violation of any such provision of such Code or Ordinance shall be punishable by fine not exceeding two hundred (\$200.00) dollars, and each day any violation of such Code or other Ordinance of the City shall continue shall constitute a separate offense, unless otherwise provided.

SECTION 3. If any phrase, clause, sentence, paragraph or section of this ordinance or the 1970 Supplement to the Code hereby adopted shall be declared unconstitutional or otherwise invalid by any court of competent jurisdiction such unconstitutionality or invalidity shall not affect the remaining portions of this ordinance or the 1970 Supplement to the Code.

SECTION 4. The fact that the 1970 Supplement to the Code has not been adopted creates an urgency and an emergency in the interest of public health, safety and welfare and necessitates that this ordinance shall take effect immediately from and after its passage and the publication of the caption of said ordinance as the law and charter in such cases provides.
