ORDINANCE NO. 1067

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AUTHORIZING MAYOR GEORGE BOYCE TO EXECUTE A DEED TO MESQUITE INDEPENDENT SCHOOL DISTRICT, CONVEYING A TRACT OF LAND CONSISTING OF THE WEST PORTION OF THE RAWLINS SCHOOL PARK SITE AND DECLARING AN EMERGENCY.

WHEREAS, the City of Mesquite, Texas, and the Mesquite Independent School District have heretofore purchased certain land for a joint school-city park site, and

WHEREAS, an error was made in the conveyance from Mesquite Independent School District to the City of Mesquite in that the west end of said tract was conveyed to the City of Mesquite when in truth and in fact it was the intention of the parties that the east portion of said tract be conveyed to said city;

WHEREAS, the Mesquite Independent School District has requested than an exchange be made to correct such error;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Honorable George Boyce, Mayor, is hereby authorized to execute a deed to Mesquite Independent School District on behalf of the City of Mesquite, conveying a tract of land described in Exhibit "A", attached hereto and made a part of this ordinance in exchange for a tract of land described in Exhibit "B", attached hereto, to effect an equitable exchange thereby.
