ORDINANCE NO. 1074

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMEND-ING ORDINANCE NO. 994, BY APPOINTING WAYNE WILLIAMS d/b/a WILLIAMS PAINT AND BODY SHOP AS THE AUTHORIZED WRECKER SERVICE OPERATOR FOR THE SOUTH MESQUITE DISTRICT; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Mesquite has heretofore designated Jack Farley, d/b/a Parkway Garage as the Authorized Wrecker Service Operator for the South Mesquite District; and

WHEREAS, the said Jack Farley has sold the said Parkway Garage to one Wayne Williams and is no longer associated with the management and control of Parkway Garage; and

WHEREAS, the said Wayne Williams has indicated a desire to continue the operation of said garage as an Authorized Wrecker Service;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Ordinance No. 994, duly passed by the City Council of the City of Mesquite on December 6, 1971, is hereby amended as follows, in all other respects to remain in full force and effect:

That phrase in Section 2-B of said Ordinance reading:

"B. South Mesquite District - Jack Farley d/b/a Parkway Garage"

is changed to read:

"B. South Mesquite District - Wayne Williams d/b/a Williams Paint and Body Shop"

SECTION 2. Should any word, phrase, sentence, paragraph, or section of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 3. Any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed to be guilty of a misdemeanor and upon conviction in the Municipal Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 4. The fact that there is no Authorized Wrecker Service Operator qualified to so act for the South Mesquite District creates an urgency and an emergency for the preservation of the public health, safety, and welfare of its citizens and requires that this ordinance shall take effect immediately from and after its passage and the publication of the caption of said ordinance, as the law in such cases provides.
