## ORDINANCE NO. 1154

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING ORDINANCE NUMBER 297 BY CLARIFYING THE LAND DESCRIPTION THEREIN; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Ordinance Number 297, duly passed by the City Council on June 6, 1960, A.D., is hereby amended to clarify the description of the land zoned to properly reflect the intent of the City Council and the Planning and Zoning Commission and the attached property description designated as Exhibit "A" is hereby deemed to be the land description of the land zoned by Ordinance Number 297. In all other respects Ordinance Number 297 is to remain in full force and effect.

SECTION 2. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 3. The fact that the description of the land zoned by Ordinance Number 297 does not clearly reflect the intent of the City Council and the Planning and Zoning Commission and tends to create questions as to the proper application of the Zoning Ordinance creates an urgency and an emergency and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance as the law in such cases provides.
