ORDINANCE NO. 1169

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, APPROVING A COMPROMISE AND SETTLEMENT AGREEMENT FOR PAYMENT OF PRINCIPAL ONLY ON CERTAIN PAVING ASSESSMENT ACCOUNTS AND AUTHORIZING THE TAX ASSESSOR-COLLECTOR TO EXECUTE RELEASES OF LIENS THEREON AND DECLARING AN EMERGENCY.

WHEREAS, certain paving assessment accounts were unpaid over a period of several years; and

WHEREAS, such accounts were probably uncollectible due to the statute of limitations; and

WHEREAS, to avoid litigation a compromise was reached whereby the property owners would pay the principal only in full settlement and satisfaction of such claims and such amounts having heretofore been paid;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the agreement reached by the City Attorney and certain property owners for payment of principal only on delinquent paving assessment accounts as a compromise and settlement of such claims is hereby approved and the Tax Assessor-Collector is hereby authorized to execute releases of the liens asserted by virtue of the assessments on the accounts listed in Exhibit "A" attached hereto.

SECTION 2. The fact that releases of lien have not been executed on the described accounts tends to obscure the state of title to certain lands and to subject the City of Mesquite to unnecessary and unfruitful litigation creates an urgency and emergency and requires that this ordinance shall take effect immediately from and after its passage and publication as the law in such cases provides.
