ORDINANCE NO. 1202

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 14A, SECTION 101 OF THE CODE OF THE CITY OF MESQUITE, BY ADDING A NEW SUBSECTION (d) PERMITTING THE USE OF PLASTIC AND NO-HUB CAST IRON PIPE AND FITTINGS WITH CERTAIN STIPULATIONS; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 14A, Section 101 of the Code of the City of Mesquite is amended by adding a new subsection (d); in all other respects to remain in full force and effect:

- "(d) Provided, however, that the following materials may be used in all structures with the stipulations listed herein:
- Plastic Pipe, minimum of Schedule 40 wall thickness, for drain, waste and vent only. Cast iron hubs will be extended through the slab for adapting the plastic pipe.
 - (i.) Pipe: The pipe shall be marked on two sides 180° apart or spirally in letters not less than 3/16 inch high in a contrasting color and shall at least consist of the manufacturers' name or trademark, nominal pipe size, the symbol of the type and the symbol D.W.V. (Drain, Waste, Vent) spaced at intervals of not more than two (2) feet.

(ii.) Fittings: All fittings shall be marked on the body or hub on both sides. The marking shall consist, at least, of the manufacturers' name or trademark, or both, and the symbol of the type of plastic pipe being used. CC212

2. No-Hub pipe, and fittings to be used above the slab and outside the slab only for drain, waste and vent is described as hubless cast iron soil pipe and fittings therefor. No-hub coupling device consists of an internally ribbed elastomeric sealing sleeve within a protective corrugated stainless steel tightening devises.

Stipulations:

- (i.) Pipe: Shall be legibly marked on the barrel of the pipe.
- (ii.) Fittings: Shall be legibly marked with manufacturers' name or trademark and shall be located at least one and onehalf (1½) inches from any end.

No-hub pipe and fittings, couplings and gaskets shall be manufactured in strict accordance with the Cast Iron Soil Pipe Institute's Standard, Number 301.

All cast iron no-hub pipe components shall be clearly marked with the manufacturers' name, initials or trademark and the Institute's registered trademark."

SECTION 2. Should any word, phrase, sentence, paragraph or section of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 3. Any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 4. The fact that the Code of the City of Mesquite, Texas, is inadequate for the necessary public interest and general welfare, creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from its passage and publication of the caption as the law in such cases provides.
