

ORDINANCE NO. 1296

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 10 OF THE CODE OF THE CITY OF MESQUITE BY DESIGNATING CERTAIN PORTIONS OF CERTAIN STREETS IN THE DOWNTOWN BUSINESS DISTRICT FOR NO PARKING AT ANY TIME, TWO HOUR PARKING DURING CERTAIN HOURS AND ESTABLISHING A TWENTY (20) MILE PER HOUR SPEED LIMIT ON A PORTION OF DAVIS STREET AND MAIN STREET; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

WHEREAS, an engineering study of traffic conditions in the Downtown Business District indicates a need for certain traffic safety controls;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 10 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

1. To the list of designated streets in Section 10-47.8 is added the following:

<u>Street</u>	<u>Extent</u>	<u>Speed (MPH)</u>
Davis	From the west curb line of Ebrite Street to the east curb line of Bryan Street.	20
Main	From the east curb line of Bryan to the west curb line of Ebrite on Main Street.	20

2. To the list of designated streets in Section 10-61.2 is added the following:

"Davis Street, both sides, from the east curb line of Gibson to the west curb line of Galloway."

3. Section 10-61.6 is hereby amended to read as follows:

"When notice is given by the erection of signs or the marking of curbs to such effect, it shall be unlawful to park or stand a vehicle for a period of more than two (2) hours on the following streets or portions thereof at the time indicated.

Dalworth	south side between Carmack Street and Gross Road	anytime
West Main	both sides, from the west curb line of Lancaster to the east curb line of Ebrite Street, except for that area designated in Ordinance No. 1156 as a taxi stand.	7:00 A.M. to 6:00 P.M. Monday thru Saturday
Davis	east curb line of Rugel Street to west curb line of Gibson Street.	7:00 A.M. to 6:00 P.M. Monday thru Saturday
Davis	east curb line of Galloway to west curb line of Bryan Street.	7:00 A.M. to 6:00 P.M. Monday thru Saturday
Broad	the 100 block of Broad Street (Town Square) on the extreme east and west sides.	7:00 A.M. to 6:00 P.M. Monday thru Saturday

SECTION 2. That all ordinances of the City of Mesquite in conflict with the provisions of this ordinance be, and the same are, hereby repealed and all other ordinances of the City of Mesquite not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be invalid, illegal or unconstitutional and shall not affect the validity of the remainder of Chapter 10 or any other provision of the Code of the City of Mesquite.

SECTION 4. That any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 5. The fact that the present ordinances of the City of Mesquite are inadequate to protect the safety and welfare of the inhabitants of the City of Mesquite, creates an urgency and an emergency and in the preservation of the public health, safety and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law and charter in such cases provides.
