ORDINANCE AUTHORIZING PUBLICATION OF NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION OF THE CITY OF MESQUITE, TEXAS

WHEREAS, it is deemed necessary and advisable by the City Council of the City of Mesquite that Notice of Intention to Issue Certificates of Obligation be given as hereinafter provided.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE:

Section 1. That attached hereto and marked "Exhibit A" is a form of Notice of Intention to Issue Certificates of Obligation, the form and substance of which are hereby adopted and approved.

Section 2. That the City Secretary shall cause said Notice of Intention to Issue Certificates of Obligation, in substantially the form attached hereto as "Exhibit A", to be published once a week for two consecutive weeks in a newspaper of general circulation in the City, the date of the first publication to be at least fourteen (14) days prior to the date tentatively set for the passage of the Ordinance authorizing the issuance of such Certificates of Obligation.

NOTICE OF INTENTION
TO ISSUE CERTIFICATES OF OBLIGATION
OF THE CITY OF MESQUITE, TEXAS

THE CITY OF MESQUITE, in Dallas County, Texas, hereby gives notice of intention to issue CITY OF MESQUITE CERTIFICATES OF OBLIGATION, SERIES 1977, in the maximum principal amount of \$310,000, for the purpose of paying contractual obligations incurred for the purchase of land needed for garbage disposal landfill sites, to-wit: a tract aggregating approximately 77 acres out of the William A. Cole Survey, Abstract No. 262, Dallas County, Texas, and a tract aggregating approximately 60 acres out of the Osborne Love Survey, Abstract No. 833, Dallas County, Texas, and paying all or a portion of the contractual obligations for professional services of attorneys and financial advisors in connection with such land and Certificates of Obligation. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law. The City Council of the City tentatively proposes to authorize the issuance of such Certificates of Obligation at 1:30 p.m. on March 7, 1977, at the Municipal Building, Mesquite, Texas.
