ORDINANCE NO. 1359

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING ORDINANCE NUMBER 926 AND ORDINANCE NUMBER 971, BY PROVIDING FOR EXPANSION OF MEMBERSHIP OF THE MESQUITE ENVIRONMENTAL IMPROVEMENT AND BEAUTIFICATION COMMISSION TO TWENTY BY PROVIDING ONE REPRESENTATIVE FROM EACH OF THE THREE MESQUITE GARDEN CLUBS AND ONE REPRESENTATIVE FROM THE MESQUITE SENIOR CITIZENS ASSOCIATION; BY PROVIDING FOR TWO-YEAR STAGGERED TERMS; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Ordinance No. 926, duly passed by the City Council on the 1st day of February, 1971, and Ordinance No. 971, duly passed by the City Council on the 7th day of September, 1971, are hereby amended by expanding the number of members of the Mesquite Environmental Improvement and Beautification Commission to twenty (20), and the class under Section 1, Paragraph B thereof to fourteen (14) and adding the following categories, to wit:

Mesquite Garden Club Kickapoo Garden Club Pots 'N Ivy Garden Club Senior Citizens Association

SECTION 2. That Ordinance No. 926, duly passed by the City Council on the 1st day of February, 1971, is hereby amended by changing the terms of membership to two (2) years for all members except the two high school representatives whose terms shall remain one year and by creating staggered terms by providing that the terms of membership of the six (6) at large members and therefour (4) members designated in Section 1 above shall expire in February of every odd-numbered year and the terms of all other members except the high school representatives shall expire in February of every even-numbered year; in all other respects to remain in full force and effect.

SECTION 3. The fact that no representatives of Mesquite garden clubs or senior citizens is provided on said Commission creates an urgency and an emergency for the preservation of the public health, comfort and welfare of the citizens of Mesquite and requires that this ordinance shall take effect after the passage of said ordinance, as the law in such cases provides.
