

ORDINANCE AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS

THE STATE OF TEXAS :
 COUNTY OF DALLAS :
 CITY OF MESQUITE :

WHEREAS, the bonds hereinafter authorized were duly and favorably voted at elections held in said City on the 7th day of February, 1970, the 23rd day of October, 1976, and the 22nd day of October, 1977; and

WHEREAS, out of the bonds voted at the election held on February 7, 1970, for various General Obligation purposes, the following previously have been issued and delivered:

\$5,745,000 out of a voted total of \$6,200,000 for the purpose of the construction and improvement of the roads, bridges, and streets of said City, including providing drainage in connection therewith, represented by the bonds of Series 1970, and part of the bonds of Series 1971, Series 1972, Series 1973, Series 1974, and Series 1977;

\$ 285,000 out of a voted total of \$500,000 for the purpose of constructing and permanently equipping an addition to the City's Public Library, represented by part of the bonds of Series 1971, Series 1972, Series 1974, and Series 1977; and

WHEREAS, out of the bonds voted at the election held on October 23, 1976, for various General Obligation purposes, the following previously have been issued and delivered:

\$ 175,000 out of a voted total of \$500,000 for the purpose of purchasing and permanently improving lands for garbage disposal (land-fill and transfer sites); and

WHEREAS, none of the Street and Drainage Bonds, Drainage and Flood Control Bonds, and Library Bonds voted at said election held on October 23, 1976, and none of the Park Bonds voted at said election held on October 22, 1977, has been authorized, issued, or delivered; and

WHEREAS, it is necessary and advisable to authorize, issue, and deliver an installment or series of said bonds; and

WHEREAS, the bonds hereinafter authorized and designated were voted and are to be issued and delivered pursuant to Vernon's Articles 823, 1175, and '081f.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE:

Section 1. That the said City's bonds are hereby authorized to be issued in the aggregate principal amount of \$1,500,000, for the purpose of providing \$585,000 FOR THE CONSTRUCTION AND IMPROVEMENT OF THE ROADS, BRIDGES, AND STREETS OF SAID CITY, INCLUDING PROVIDING DRAINAGE IN CONNECTION THEREWITH; \$215,000 FOR CONSTRUCTING AND PERMANENTLY EQUIPPING AN ADDITION TO THE CITY'S PUBLIC LIBRARY; \$135,000 FOR CONSTRUCTING PERMANENT DRAINAGE AND FLOOD CONTROL IMPROVEMENTS FOR SAID CITY; \$85,000 FOR CONSTRUCTING AND PERMANENTLY EQUIPPING PUBLIC LIBRARIES; \$180,000 FOR PURCHASING AND PERMANENTLY IMPROVING LANDS FOR GARBAGE DISPOSAL (LANDFILL AND TRANSFER SITES); AND \$300,000 FOR PURCHASING AND PERMANENTLY IMPROVING LANDS FOR PARK RECREATION PURPOSES.

Section 2. That said bonds shall be designated as the: "CITY OF MESQUITE GENERAL OBLIGATION BONDS, SERIES 1978".

Section 3. That said bonds shall be dated DECEMBER 1, 1978, shall be in the denomination of \$5,000 each, shall be numbered consecutively from one upward, and shall mature serially on the maturity date, in each of the years, and in the amounts, respectively, as set forth in the following schedule:

Said interest shall be evidenced by interest coupons which shall appertain to said bonds, and which shall be payable in the manner provided and on the dates stated in the FORM OF BOND set forth in this Ordinance.

Section 5. That said bonds and interest coupons shall be issued, shall be payable, may be redeemed prior to their scheduled maturities, shall have the characteristics, and shall be signed and executed (and said bonds shall be sealed), all as provided, and in the manner indicated, in the FORM OF BOND set forth in this Ordinance.

Section 6. That the form of said bonds, including the form of Registration Certificate of the Comptroller of Public Accounts of the State of Texas to be printed and endorsed on each of said bonds, and the form of the aforesaid interest coupons which shall appertain and be attached initially to each of said bonds, shall be, respectively, substantially as follows:

and to pay interest thereon, from date hereof, at the rate of _____ % per annum, evidenced by interest coupons payable JUNE 1, 1979, and semiannually thereafter while this bond is outstanding.

THE PRINCIPAL of this bond and the interest coupons appertaining hereto shall be payable to bearer, in lawful money of the United States of America, without exchange or collection charges to the bearer, upon presentation and surrender of this bond or proper interest coupon, at the following, which shall constitute and be defined as the "Paying Agent" for this Series of bonds:

THIS BOND is one of a Series dated as of DECEMBER 1, 1978, authorized, issued, and delivered in the principal amount of \$1,500,000 for the purpose of providing \$585,000 FOR THE CONSTRUCTION AND IMPROVEMENT OF THE ROADS, BRIDGES, AND STREETS OF SAID CITY, INCLUDING PROVIDING DRAINAGE IN CONNECTION THEREWITH; \$215,000 FOR CONSTRUCTING AND PERMANENTLY EQUIPPING AN ADDITION TO THE CITY'S PUBLIC LIBRARY; \$135,000 FOR CONSTRUCTING PERMANENT DRAINAGE AND FLOOD CONTROL IMPROVEMENTS FOR SAID CITY; \$85,000 FOR CONSTRUCTING AND PERMANENTLY EQUIPPING PUBLIC LIBRARIES; \$180,000 FOR PURCHASING AND PERMANENTLY IMPROVING LANDS FOR GARBAGE DISPOSAL (LANDFILL AND TRANSFER SITES); AND \$300,000 FOR PURCHASING AND PERMANENTLY IMPROVING LANDS FOR PARK RECREATION PURPOSES.

ON JUNE 1, 1991,

or on any interest payment date thereafter, any outstanding bonds of this Series may be redeemed prior to their scheduled maturities, at the option of said City, in whole, or in part, for the principal amount thereof and accrued interest thereon to the date fixed for redemption. At least thirty days prior to the date fixed for any such redemption said City shall cause a written notice of such redemption to be published at least once in a financial publication published in the City of New York, New York. By the date fixed for any such redemption due provision shall be made with the "Paying Agent" for the payment of the principal amount of the bonds which are to be so redeemed and accrued interest thereon to the date fixed for redemption. If such written notice of redemption is published and if due provision for such payment is made, all as provided above, the bonds which are to be so redeemed thereby automatically shall be redeemed prior to their scheduled maturities, and they shall not bear interest after the date fixed for redemption, and they shall not be regarded as being outstanding except for the right of the bearer to receive the redemption price from the "Paying Agent" out of the funds provided for such payment.

IT IS HEREBY certified, recited, and covenanted that this bond has been duly and validly voted, authorized, issued, and delivered; that all acts, conditions, and things required or proper to be performed, exist, and be done precedent to or in the voting, authorization, issuance, and delivery of this bond have been performed, existed, and been done in accordance with law; that this bond is a general obligation of said City, issued on the full faith and credit thereof; and that annual ad valorem taxes sufficient to provide for the payment of the interest on and principal of this bond, as such interest comes due and such principal matures, have been levied and ordered to be levied against all taxable property in said City, and have been pledged irrevocably for such payment, within the limit prescribed by law.

IN WITNESS WHEREOF, this bond and the interest coupons ap-

pertaining hereto have been signed with the facsimile signature of the Mayor of said City and countersigned with the facsimile signature of the City Secretary of said City, and the official seal of said City has been duly impressed, or placed in facsimile, on this bond.

Section 7. That a special "Interest and Sinking Fund" is hereby created solely for the benefit of said bonds, and said Interest and Sinking Fund shall be established and maintained by said City at an official depository bank of said City. Said Interest and Sinking Fund shall be kept separate and apart from all other funds and accounts of said City, and shall be used only for paying the interest on and principal of said bonds. All ad valorem taxes levied and collected for and on account of said bonds shall be deposited, as collected, to the credit of said Interest and Sinking Fund. During each year while any of said bonds or interest coupons appertaining thereto are outstanding and unpaid, the governing body of said City shall compute and ascertain a rate and amount of ad valorem tax which will be sufficient to raise and produce the money required to pay the interest on said bonds as such interest comes due, and to provide and maintain a sinking fund adequate to pay the principal of such bonds as such principal matures (but never less than 2% of the original principal amount of said bonds as a sinking fund each year); and said tax shall be based on the latest approved tax rolls of said City, with full allowance being made for tax delinquencies and the cost of tax collection. Said rate and amount of ad valorem tax is hereby levied, and is hereby ordered to be levied, against all taxable property in said City for each year while any of said bonds or interest coupons appertaining thereto are outstanding and unpaid; and said tax shall be assessed and collected each such year and deposited to the credit of the aforesaid Interest and Sinking Fund. Said ad valorem taxes sufficient to provide for the payment of the interest on and principal of said bonds, as such interest comes due and such principal matures, are hereby pledged irrevocably for such payment, within the limit prescribed by law.

Section 8. That there is hereby appropriated from surplus funds of the City lawfully available for such purpose, and shall be deposited into the aforesaid Interest and Sinking Fund the amount of money required to pay the interest coming due on said bonds on June 1, 1979. The money thus appropriated and deposited shall be used for no purpose other than to pay said interest. The appropriate City officials are hereby authorized and directed to do any and all things necessary or convenient to accomplish said appropriation and deposit.

Section 9. That the Mayor of said City is hereby authorized to have control of said bonds and all necessary records and proceedings pertaining to said bonds pending their delivery and their investigation, examination, and approval by the Attorney General of the State of Texas, and their registration by the Comptroller of Public Accounts of the State of Texas. Upon registration of said bonds, said Comptroller of Public Accounts (or a deputy designated in writing to act for said Comptroller) shall manually sign the Comptroller's Registration Certificate

printed and endorsed on each of said bonds, and the seal of said Comptroller shall be impressed, or placed in facsimile, on each of said bonds.

Section 10. That the City covenants to and with the purchaser of the bonds that it will make no use of the proceeds of the bonds at any time throughout the term of this issue of bonds which, if such use had been reasonably expected on the date of delivery of the bonds to and payment for the bonds by the purchasers, would have caused the bonds to be arbitrage bonds within the meaning of Section 103(c) of the Internal Revenue Code of 1954, as amended, or any regulations or rulings pertaining thereto; and by this covenant the City is obligated to comply with the requirements of the aforesaid Section 103(c) and all applicable and pertinent Department of the Treasury regulations relating to arbitrage bonds. The City further covenants that the proceeds of the bonds will not otherwise be used directly or indirectly so as to cause all or any part of the bonds to be or become arbitrage bonds within the meaning of the aforesaid Section 103(c), or any regulations or rulings pertaining thereto.


Section 11. That it is hereby officially found and determined: that a case of emergency or urgent public necessity exists which requires the holding of the meeting at which this Ordinance is passed, such emergency or urgent public necessity being that the proceeds from the sale of said bonds are required as soon as possible and without delay for necessary and urgently needed public improvements; and that said meeting was open to the public, and public notice of the time, place, and purpose of said meeting was given, all as required by Vernon's Ann. Civ. St. Article 6252-17.

Section 12. That said bonds are hereby sold and shall be delivered to C&C Southwest and Assoc. for cash for the par value thereof and accrued interest thereon to date of delivery, plus a premium of \$ -0-. It is hereby officially found, determined, and declared that said bonds have been sold at public sale to the bidder offering the lowest interest cost, after receiving sealed bids pursuant to an Official Notice of Sale and Official Statement dated November 3, 1978, prepared and distributed in connection with the sale of said bonds. Said Official Notice of Sale and Official Statement have been and are hereby approved by the City Council. It is further officially found, determined, and declared that the statements and representations contained in said Official Notice of Sale and Official Statement are true and correct in all material respects, to the best knowledge and belief of the City Council.


