AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMEND-ING SECTION 10-47.8, CHAPTER X, OF THE CODE OF THE CITY OF MESQUITE BY AMENDING THE MAXIMUM SPEED LIMIT ON THE PORTION OF SCYENE ROAD FROM THE WEST CITY LIMIT EAST TO THE INTERSECTION OF MILITARY PARKWAY; BY PROVIDING THAT ALL ORDINANCES IN CONFLICT WITH THIS ORDINANCE ARE REPEALED TO THE EXTENT OF SUCH CONFLICT AND THAT SECTION 10-47.8, CHAPTER X, IN ALL OTHER RESPECTS, SHALL REMAIN IN FULL FORCE AND EFFECT; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00); AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 10-47.8, Chapter X, of the Code of the City of Mesquite is hereby amended as follows; in all other respects to remain in full force and effect:

That the following language is hereby deleted:

Scyene Road - From the west City limit east to the intersection of Military Parkway

All other sections of the foregoing streets and highways shall remain as zoned.

SECTION 2. That all of the speed limits set forth in this section are subject to all other specific restrictions upon speeds for specific areas and where a lesser speed limit is indicated, such as in a school zone, the lesser maximum limit shall control in the location and during the hours applicable.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 4. That any person violating any of the provisions of this ordinance shall be deemed guilty of a Class C misdemeanor and upon conviction in Municipal Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.
