

ORDINANCE NO. 1571

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THE CODE OF THE CITY OF MESQUITE, TEXAS, TO PROVIDE FOR REVISED PERMIT FEES FOR CERTAIN BUILDING, PLUMBING, ELECTRICAL, AIR-CONDITIONING AND VENTILATING ADDITIONS, ALTERATIONS, AND REPAIRS; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Section 2B-13, paragraph (b), subparagraph entitled "Additions, Alterations and Repairs, All Groups" shall be and is hereby amended to read as follows, in all other respects said Section to remain in full force and effect:

"Additions, Alterations and Repairs, All Groups"

SECTION 2. That Section 5-7.5, paragraph (c), subparagraph entitled "Additions, Alterations and Repairs, All Groups" shall be and is hereby amended to read as follows, in all other respects said Section to remain in full force and effect:

SECTION 3. That Section 7-10, paragraph (c), subparagraph entitled "Additions, Alterations and Repairs, All Groups" shall be and is hereby amended to read as follows, in all other respects said Section to remain in full force and effect:

SECTION 4. That Section 14A-36, paragraph c, subparagraph entitled "Additions, Alterations and Repairs, All Groups" shall be and is hereby amended to read as follows, in all other respects said Section to remain in full force and effect:


SECTION 5. Should any word, phrase, sentence, paragraph, or section of this Ordinance be held to be invalid or unconstitutional the remaining provisions shall not be affected because of such invalidity or unconstitutionality.

SECTION 6. The fact that the code of the City of Mesquite is inadequate to establish the proper permit fees for building, plumbing, electrical, air-conditioning and ventilating additions, alterations, and repairs creates an urgency and an emergency for the preservation of the public health, safety and welfare and requires that this ordinance shall take effect immediately from its passage and publication as the law in such cases provide.
