

ORDINANCE NO. 1744

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS,
AMENDING SECTION 10-61.2, SECTION 10-61.6,
AND SECTION 10-47.5 OF THE CODE OF THE CITY
OF MESQUITE; BY PROVIDING A SEVERABILITY
CLAUSE; BY PROVIDING A PENALTY NOT TO EXCEED
TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE;
AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF MESQUITE, TEXAS:

SECTION 1. That Section 10-61.2 of the Code of the City of
Mesquite is hereby amended as follows; in all other respects said
section and code to remain in full force and effect:

"When signs are erected or curbs marked giving notice
to such effect, no person shall park or leave standing a
vehicle at any time upon the portions of the streets
described below:

1. To the list of designated streets in Section
10-61.2 the following is added:

Belt Line Road between Range Drive and Tripp Road

North Service Road of U.S. Highway 80 from Exit Ramp
East of Belt Line Road to Entrance Ramp West of Belt
Line Road

South Service Road of U.S. Highway 80 from Exit Ramp
West of Belt Line Road to Entrance Ramp East of Belt
Line Road."

SECTION 2. That Section 10-61.6 of the Code of the City of
Mesquite is hereby amended as follows, in all other respects said
section and code to remain in full force and effect:

"When notice is given by the erection of signs or
the marking of curbs to such effect, it shall be unlaw-
ful to park or stand a vehicle for a period of more than
two (2) hours on the following streets or portions thereof:

Gibson Street between College Street and Davis Street.

SECTION 3. That Section 10-47.5 of the Code of the City of Mesquite is amended as follows, in all other respects to remain in full force and effect:

The following streets and portions thereof are hereby designated as school zones for the school indicated from 7:30 A.M. to 9:00 A.M. and from 2:00 P.M. to 4:00 P.M., and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent.

1. To the list of designated streets in Section 10-47.5, the following are added:


<u>SCHOOL</u>	<u>LOCATION</u>
McDonald Middle School	On Town East Blvd. from 124 feet east of Eastridge Dr. to Tedlow Trail
	On Town East from John Glenn Parkway to 100 feet east of Edgebrook

SECTION 4. Should any word, phrase, sentence, paragraph, or section of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.


SECTION 5. Any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed to be guilty of a misdemeanor and upon conviction in the Municipal Court shall be subject to a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 6. The fact that the Code of the City of Mesquite, Texas, is inadequate for the necessary protection of the public comfort and general welfare creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from its passage and publication as the law in such cases provide.
