

ORDINANCE NO. 1754

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 10-47.8, CHAPTER X OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING NEW LANGUAGE THEREFORE TO CLARIFY CERTAIN SPEED LIMIT LOCATIONS ALONG NORTH GALLOWAY AVENUE AND SOUTH GALLOWAY AVENUE; BY PROVIDING THAT ALL ORDINANCES IN CONFLICT WITH THIS ORDINANCE ARE REPEALED TO THE EXTENT OF SUCH CONFLICT AND THAT SECTION 10-47.8, CHAPTER X, IN ALL OTHER RESPECTS, SHALL REMAIN IN FULL FORCE AND EFFECT; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 10-47.8, Chapter X of the Code of the City of Mesquite shall be amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Section 10-47.8, Chapter X of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED (MPH)</u>
<u>North Galloway Avenue</u>	From a point 50 feet North of Kearney St. north to Grubb Dr.	35
<u>South Galloway Avenue</u>	From a point 50 feet south of the South curbline of Borchardt St. and South Galloway Avenue, north to a point fifty feet north of the north curb line of Kearney St. and North Galloway Avenue	30

<u>South Galloway Ave.</u>	From the south right of way line of New Market Road, North on South Galloway to a point fifty feet south of the south curb line of Borchardt Street and South Galloway Ave.	35

The Following language shall be added to section 10-47.8, Chapter X of the Code of the City of Mesquite:

<u>North Galloway Ave.</u>	From its Intersection with Kearney St., north to its intersection with Grubb Drive	35
----------------------------	--	----

<u>South Galloway Ave.</u>	From its intersection with Borchardt street, north to the intersection of Kearney Street and North Galloway Avenue	30
----------------------------	--	----

<u>South Galloway Ave.</u>	From its intersection with New Market Road, north to its intersection with Borchardt Street	35

SECTION 2. That all ordinances of the City of Mesquite in conflict with the provisions of this Chapter be, and the same are, hereby repealed to the extent of such conflict and ordinances not in conflict herewith shall remain in full force and effect.


SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 4. That any person violating any of the provisions of this ordinance shall be deemed guilty of a Class C Misdemeanor and upon conviction in Municipal Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 5. The fact that the present ordinances of the City of Mesquite do not adequately and clearly set out certain speed limits regulating the speed of motor vehicles along North Galloway Ave. and South Galloway Ave., creates an urgency and emergency in the preservation of the public health, safety and welfare requires that this ordinance shall take effect immediately from and after


its passage and the publication of the caption as the law and charter in such cases provide.
