

ORDINANCE NO. 1768

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 10-47.8, CHAPTER X OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING NEW LANGUAGE THEREFORE TO CHANGE CERTAIN SPEED LIMIT LOCATIONS ALONG GROSS ROAD; BY PROVIDING THAT ALL ORDINANCES IN CONFLICT WITH THIS ORDINANCE ARE REPEALED TO THE EXTENT OF SUCH CONFLICT AND THAT SECTION 10-47.8, CHAPTER X, IN ALL OTHER RESPECTS, SHALL REMAIN IN FULL FORCE AND EFFECT; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 10-47.8, Chapter X of the Code of the City of Mesquite shall be amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Section 10-47.8, Chapter X of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED (MPH)</u>
GROSS ROAD	From a point 100 feet south of the south curblin of Jane Street and Gross Road south to a point 100 feet north of the north curblin of Grubb Drive and Gross Rd.	

The following language shall be added to Section 10-47.8, Chapter X of the Code of the City of Mesquite:

GROSS ROAD	From a point 100 feet south of its intersection with Jane Street south to its intersection with Chappell.	40

SECTION 2. That all ordinances of the City of Mesquite in conflict with the provisions of this Chapter be, and the same are, hereby repealed to the extent of such conflict and ordinances not in conflict herewith shall remain in full force and effect.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 4. That any person violating any of the provisions of this ordinance shall be deemed guilty of a Class C Misdemeanor and upon conviction in Municipal Court shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.


SECTION 5. The fact that the present ordinances of the City of Mesquite do not adequately and clearly set out certain speed limits regulating the speed of motor vehicles along Gross Road, creates an urgency and emergency in the preservation of the public health, safety and welfare and requires that this ordinance shall take effect immediately from and after its passage and the publication of the caption as the law and charter in such cases provide.
