AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF 1973, DULY PASSED BY THE CITY COUNCIL ON SEPTEMBER 4, 1973, SO AS TO GRANT A CHANGE OF ZONING FROM A-2, PLANNED DEVELOPMENT TOWNHOUSE AND PLANNED DEVELOPMENT DUPLEX TO PLANNED DEVELOPMENT INDUSTRIAL ON TRACT 1; FROM R-3, OFFICE AND PLANNED DEVELOPMENT TOWNHOUSE TO PLANNED DEVELOPMENT RESIDENTIAL ON TRACT 2; FROM AGRICULTURAL TO INDUSTRIAL ON TRACT 3; FROM AGRIGULTURAL TO PLANNED DEVELOPMENT INDUSTRIAL WITH THE STIPULATIONS AS FOLLOWS: THAT ALL CONSTRUCTION SHALL HAVE A 200-FOOT SETBACK FROM NEWSOM ROAD, VISUAL SCREENING, 6-FOOT BERMS WITH 4 TO 1 SLOPE, LANDSCAPING; THAT ACCESS SHALL BE GRANTED ONLY FROM CLAY ROAD, BERRY ROAD AND THE COUNTY THOROUGHFARE; AND ALL BUILDINGS SHALL BE OF 100% MASONRY CONSTRUCTION ON TRACT 4; FROM AGRICULTURAL TO INDUSTRIAL ON TRACT 5 AND TRACT 6; SAID PROPERTY BEING LOCATED GENERALLY SOUTH OF SCYENE ROAD, EAST OF PIONEER ROAD, NORTH OF NEWSOM ROAD AND BERRY ROAD TO THE EASTERN BOUNDARY OF THE CITY ALONG LAWSON ROAD, CITY OF MESQUITE, DALLAS COUNTY, TEXAS, AND BEING MORE FULLY DESCRIBED IN EXHIBIT "A" ATTACHED HERETO AND MADE A PART OF THIS ORDINANCE; BY REPEALING ALL ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE AND RETAINING IN FULL FORCE AND EFFECT ALL REGULATIONS OF THE 1973 ZONING ORDINANCE TO THE LAND HEREWITH ZONED; BY PROVIDING THAT THE FOREGOING CHANGES ARE GRANTED SUBJECT TO ANY DEVELOPMENT OF THE LAND BEING DEVELOPED IN CONFORMITY WITH THE REQUIREMENTS OF CURRENT AND/OR FUTURE DRAINAGE IMPROVEMENT ORDINANCES; BY PROVIDING A SEVER-ABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

WHEREAS, the City Planning Commission of the City of Mesquite and the governing body of the City of Mesquite in compliance with the Charter of the City of Mesquite and State Laws with reference to granting of zoning change under the Zoning Ordinance Regulations and Zoning Map, have given the requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property cwners generally and to the persons interested and situated in the area, the City of Mesquite is of the opinion that the change of zoning may be granted herein:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

That the Comprehensive Zoning Ordinance of 1973, SECTION 1. duly passed by the City Council of the City of Mesquite, Texas, on the 4th day of September, 1973, be and the same is hereby amended by amending the Zoning Map of the City of Mesquite so as to grant a change of zoning from A-2, Planned Development Townhous and Planned Development Duplex to Planned Development Industrial on Tract 1; From R-3 Office and Planned Development Townhouse to Planned Development Residential on Tract 2; From Agricultural to Industrial on Tract 3; From Agricultural to Planned Development Industrial with the stipulations as follows: That all construction shall have a 200-foot setback from Newsom Road, visual screening, 6-foot berms with 4 to 1 slope, landscaping; that access shall be granted only from Clay Road, Berry Road and the County thoroughfare; and all buildings shall be of 100% masonry construction on Tract 4; from agricultural to industrial on tract 5 and tract 6; said property being located generally south of Scyene Road, East of Pioneer Road, North of Newsom Road and Berry Road to the Eastern Boundary of the City Along Lawson Road, City of Mesquite, Dallas County, Texas, and being more fully described in Exhibit "A" attached hereto.

SECTION 2. That all ordinances, or portions thereof, of the City of Mesquite in conflict with the provisions of this ordinance, to the extent of such conflict are hereby repealed. To the extent that such ordinances or portions thereof not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That the property described in Section 1 of this ordinance, shall be used only in the manner and for the purposes provided for by the Comprehensive Zoning Ordinance of 1973.

SECTION 4. That the foregoing change shall be, and it is, granted subject to any development of the land herein being developed in conformity with the requirements of current and/or future drainage improvement ordinances of the City of Mesquite, including Ordinance No. 1249 of the Mesquite City Code.

SECTION 5. That should any paragraph, sentence, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be invalid, illegal, or unconstitutional and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

SECTION 6. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 7. Whereas, the property described in Section 1 of this ordinance requires that it be given the above classification in order to permit its proper development and in order to protect the public interest, comfort, and general welfare of the City of Mesquite, creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.

Being a tract, lot or parcel of land, situated in the City of Mesquite, Dallas County, Texas, and being out of the Thomas Scott Survey, Abstract No. 1353 and the Samuel Andrews Survey, Abstract No. 40, being described by metes and bounds as follows:

BEGINNING at the intersection of the west line of State Highway No. 352 with the south right of way line of Scyene Road;

THENCE south 83°59'38" east with said south right of way line of Scyene Road 1320.05 feet to a point;

THENCE south 6 000'22" west 30.0 feet to a point;

THENCE south 89 56'20" east 224.98 feet to a point;

THENCE south 83 ° 59'38" east 904.15 feet to a point;

THENCE north 60 00'22" east 30.0 feet to a point;

THENCE south 830 59'38" east 561.42 feet to a point;

THENCE along said curve to the right 485.52 feet to a point;

TYENCE north 73° 37'57" west 1243.76 feet to a point; said point being in the east boundary line of the Mesquite Highland Addition to the City of Mesquite;

THENCE north 0° 14'13" west with said east boundary of Mesquite Highland Addition to City of Mesquite 154.6 feet to the south right of way line of State Highway No. 352;

THENCE in a northeasterly direction along a curve to the left having a Delta of 41° 27'20", R=850.0', a distance of 615.02 to a point;
