ORDINANCE NO. 1960

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 10 OF THE CODE OF THE CITY OF MESQUITE BY ESTABLISHING A "NO U-TURN" LOCATION; A THIRTY-FIVE MILE PER HOUR SPEED ZONE, A "NO PARKING AT ANY TIME" ZONE AND A "NO PARKING BE-TWEEN 7:00 A.M. TO 9:00 A.M. AND 4:00 P.M. TO 6:00 P.M. ZONE; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT EXCEED TWO HUNDRED DOLLARS (\$200.00) AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. The code of the City of Mesquite is hereby amended by amending Chapter 10, "Motor Vehicles and Traffic" as follows, in all other respects to remain in full force and effect:

(1) Section 10-33.12(2) is hereby amended by adding to the locations where "U"-Turns are prohibited the following location:

Town East Boulevard at Baker Drive

(2) Section 10-47.8 is hereby amended by adding the following speed zone:

(3) Section 10-61.2 is hereby amended by adding the following No Parking at any time zone.

> Morningside Drive, North side - from Northwest Drive to alley behind Harbinger Drive

(4) Section 10-61.7 is hereby amended by adding the following No Parking during designated times zone:

STREET EXTENT TIME

From Northwest Drive to 7:00 A.M. to 9:00 Morningside Drive alloy behind Harbinger A.M. and 4:00 P.M. south side Drive to 6:00 P.M.

EMERGENCY CLAUSE: The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
