AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ABANDONING A PORTION OF BRYAN AVENUE ADJACENT TO THE APPLE TREE ACRES CHILD CARE CENTER LOCATED AT NORTH BRYAN-BELT LINE AND AUTHORIZING THE MAYOR TO EXECUTE QUIT CLAIM DEEDS TO O. B. SMITH AND PAT SMITH; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the portion of North Bryan-Belt Line adjacent to the Apple Tree Acres Child Care Center, City of Mesquite, Dallas County, Texas, and described in Exhibit "A" attached hereto, shall be, and the same is hereby abandoned.

SECTION 2. That the Mayor of the City of Mesquite, Texas, is hereby authorized to execute Quitclaim Deeds to O. B. Smith and Pat Smith.

SECTION 3. That the orderly development of the City of Mesquite requires that the portion of Bryan Avenue adjacent to the Apple Tree Acres Child Care Center as described in Exhibit "A" be abandoned creates an urgency and an emergency in the public interest and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of the caption as the law in such cases provides.
