AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER X, SECTION 10-47.8, OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING NEW LANGUAGE THEREFORE TO CHANGE THE SPEED LIMIT ALONG A PORTION OF U.S. HWY. 80 AND PROVIDE FOR A SPEED LIMIT ON A PORTION OF PEACHTREE ROAD; AND AMENDING CHAPTER X, SECTION 10-33.12 OF THE CODE OF THE CITY OF MESQUITE BY ESTABLISHING AND AUTHORIZING A CERTAIN TRAFFIC CONTROL DEVICE ON KEARNEY STREET AS AN OFFICIAL TRAFFIC CONTROL DEVICE OF THE CITY OF MESQUITE; AND AMENDING CHAPTER X, SECTION 10-61.2 OF THE CODE OF THE CITY OF MESQUITE BY PROHIBITING PARKING ON PORTIONS OF MCKINNEY AND HYDE PARK DRIVE; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENCE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter X, Section 10-47.8 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X, Section 10-47.8 of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED</u> (MPH)
U.S. Highway 80	One-half mile on either side of Galloway Avenue, during the State Construction Project.....	40

The following language shall be added to Chapter X, Section 10-47.8 of the Code of the City of Mesquite:

Peachtree Road	From Skyline Drive to Military Parkway.....	35

SECTION 2. That Chapter X, Section 10-33.12 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be added to Chapter X, Section 10-33.12 of the Code of the City of Mesquite:

No U-Turn Sign:

Kearney Street at median opening west of Galloway Avenue.

SECTION 3. That Chapter X, Section 10-61.2 of the Code of the City of Mesquite shall be amended as follows, in all other respects to remain in full force and effect.

The following language shall be added to Chapter X, Section 10-61.2 of the Code of the City of Mesquite, which prohibits parking at any time on certain designated streets:

McKinney, both sides from South Galloway Avenue to Lawrence.

Hyde Park Drive, East side of 3700 block from the North curb line of U.S. Highway 67 North Service Road to the south curb line of Susan Drive.

SECTION 4. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 5. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed guilty of a misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 6. That the ordinances of the City of Mesquite are inadequate to control the rate of speed, u-turns, and parking on certain public streets creates an urgency and emergency in the preservation of the public health, safety and welfare and requires that this ordinance shall become effective immediately from and after its passage and the publication of the caption, as the law and charter in such cases provides.
