

## ORDINANCE NO. 2076

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER 14A, CODE OF THE CITY OF MESQUITE BY ADOPTING THE 1982 EDITION OF THE UNIFORM PLUMBING CODE WITH CERTAIN AMENDMENTS AND DELETIONS AND PROVIDING AN EFFECTIVE DATE FOR APPLICATION OF THE CODE TO WORK PERMITTED AFTER SUCH DATE; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 14A, Code of the City of Mesquite, Texas is hereby amended as follows, in all other respects to remain in full force and effect:

A. Section 14A-1 is hereby amended by changing the year, "1979" Edition to read "1982" Edition.

B. Section 14A-1.1, Amendments and Deletion is hereby amended as follows:

DELETIONS

1. The following items from Table A, "Plumbing Materials Standards" are hereby deleted:

Polyethylene pipe and fittings for water Homogenous bituminized fiber drain and sewer pipe  
 PVC material gas yard piping  
 PVC pipe and fittings with rubber gasket joints for cold water  
 Copper and Copper alloy welded water tubes (installation)  
 Welded Copper alloy water tube  
 Welded Copper alloy (C21000) water tube  
 Chlorinated poly (vinyl chloride) (CPVC) plastic pipe, schedules 40 and 80  
 Chlorinated poly (vinyl chloride) (CPVC) plastic hot water distribution systems  
 Polyethylene (PE) cold water buildings supply and yard piping and tubing (installation)  
 Polyethylene (PE) plastic pipe (SDR-PR)  
 Socket type chlorinated poly (vinyl chloride) (CPVC) plastic pipe fittings schedule 40  
 Socket type chlorinated poly (vinyl chloride) (CPVC) plastic pipe fittings schedule 80  
 Solvent cements for chlorinated poly (vinyl chloride) (CPVC) plastic pipe and fittings  
 Plumbing fixtures:  
   Plastic bathtub units  
   Plastic shower receptors and shower stalls  
   Plastic lavatories

(2) The language under "Amendments", "Section 203 (a) is amended by changing the last letter group (DWV) to L" is deleted

AMENDMENTS

Table A, Plumbing materials Standards (P.23) is amended by changing the term Polyethylene (PE3406) Natural Gas Yard Piping to PE2306.

Section 1214, Appliance Connectors, Subsection (a) is amended by adding after subparagraph (A) 7:

"The exceptions under paragraph (a) herein shall apply to residential type occupancies only."

Section 14A-1.1 (d) is amended by changing the date "March 15, 1982" to October 1, 1984.

SECTION 2. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

Section 4. The fact that the present ordinances of the City of Mesquite are inadequate to protect the health and welfare the inhabitants of the City of Mesquite creates an urgency and an emergency and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of its caption as the law in such cases provides.
