AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF 1973 DULY PASSED BY THE CITY COUNCIL ON SEPTEMBER 4, 1973, BY EFFECTING CERTAIN CHANGES IN ARTICLES 40, 41, 42, 43, 43A, 44 AND 45; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

WHEREAS, the City Planning Commission of the City of Mesquite and the governing body of the City of Mesquite in compliance with the Charter of the City of Mesquite and State Laws with reference to granting of zoning change under the Zoning Ordinance Regulations and Zoning Map, have given the requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally, the City of Mesquite is of the opinion that the following amendments and revisions should be made to the City of Mesquite Comprehensive Zoning Ordinance:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Comprehensive Zoning Ordinance duly passed by the City Council on the 4th day of September, 1973 is hereby amended as follows, in all other respects to remain in full force and effect:

- A. That Articles 40.07, 40.071, 40.072, 41.07, 41.071, 41.072, 43.08, 43.081, 43.082, 43A.07, 43A.071, 43A.072, 44.06 are hereby deleted.
- B. New Articles 40.07, 41.07 and 43.08 are hereby adopted to read as follows:

All main buildings shall be of one hundred (100%) percent exterior fire resistant construction (i.e. having exterior walls constructed of brick, stone, concrete block or other masonry, or materials of equal fire resistant characteristics). Exterior wood shall be permitted for the purpose of decor. The maximum surface area where wood decor is permissible shall not exceed twenty-five (25%) percent of any one wall and shall be limited to 35 feet in height.

C. New Articles 43A.07 and 44.06 are hereby adopted to read as follows:

All main buildings shall be of one hundred (100%) percent exterior fire resistant construction (i.e. having exterior

walls constructed of brick, stone, concrete block or other masonry, or materials of equal fire resistant characteristics). Exterior wood shall be permitted for the purpose of decor. The maximum surface area where wood decor is permissible shall not exceed twenty-five (25%) percent of any one wall and shall be limited to 35 feet in height. Butler or Deltatype steel buildings with masonry fronts are allowed only after obtaining approval as a conditional use.

- D. Existing Article 41A.04 is hereby renumbered 41A.041 and a new Article 41A.04 is hereby adopted to read as follows:
  - All main buildings shall be of one hundred (100%) percent exterior fire resistant construction (i.e. having exterior walls constructed of brick, stone, concrete block or other masonry, or materials of equal fire resistant characteristic). Exterior wood shall be permitted for the purpose of decor. The maximum surface area where wood decor is permissible shall not exceed twenty-five (25%) percent of any one wall and shall be limited to 35 feet in height.
- E. Article 42.07 is hereby amended by changing the reference therein to read 41.07 in lieu of the reference 41.071 and 41.072.
- F. Article 45.07 is hereby amended by changing the references 43A.07, 43A.071 and 43A.072 to 43A.07.
- SECTION 2. That all ordinances, or portions thereof, of the City of Mesquite in conflict with the provisions of this ordinance, to the extent of such conflict are hereby repealed. To the extent that such ordinances or portions thereof not in conflict herewith, the same shall remain in full force and effect.
- SECTION 3. That the property described in Section 1 of this ordinance, shall be used only in the manner and for the purposes provided for by the Comprehensive Zoning Ordinance of 1973.
- SECTION 4. That the foregoing change shall be, and it is, granted subject to any development of the land herein being developed in conformity with the requirements of current and/or future drainage improvement ordinances of the City of Mesquite, including Ordinance No. 1249 of the Mesquite City Code.
- SECTION 5. That should any paragraph, sentence, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be invalid, illegal, or unconstitutional and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

SECTION 6. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 7. Whereas, the property described in Section 1 of this ordinance requires that it be given the above classification in order to permit its proper development and in order to protect the public interest, comfort, and general welfare of the City of Mesquite, creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
