AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 10-61.2 OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE DESCRIBING CERTAIN STREETS AND ADD-ING NEW LANGUAGE PROVIDING THAT WHEN NOTICE IS GIVEN BY THE POSTING OF SIGNS OR MARKING OF CURBS, PARKING AND STANDING OF VEHICLES SHALL BE PROHIBITED ON BOTH SIDES OF EAST MEADOW BOULEVARD FROM U.S. HIGHWAY 80 TO I.H. 30; ON BOTH SIDES OF U.S. HIGHWAY 80 NORTH SERVICE ROAD FROM NORTH GALLOWAY TO FRANKLIN DRIVE; ON BOTH SIDES OF GUS THOMASSON ROAD FROM U.S. HIGHWAY 80 TO NORTH CITY LIMITS; ON BOTH SIDES OF NORTH MESQUITE DRIVE FROM TOWNE CENTRE DRIVE TO GUS THOMASSON; ON BOTH SIDES OF FRANKLIN DRIVE FROM U.S. HIGHWAY 80 TO TOWNE CENTRE DRIVE, AND ON BOTH SIDES OF NORTH GALLOWAY AVENUE FROM GRUBB DRIVE TO U.S. HIGHWAY 80; BY PROVIDING A SEVERABILTTY CLAUSE; BY PRO-VIDING A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS; AND DECLARING AN EMER-GENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Section 10-61.2 of the Code of the City of Mesquite is hereby amended as follows; in all other respects said section and code to remain in full force and effect:

"When signs are erected or curbs marked giving notice to such effect no person shall park or leave standing a vehicle at anytime upon the portions of the streets described below:"

To the list of designated streets in Section 10-61.2 the following is deleted:

Gus Thomasson Road, both sides from Interstate 30 to Town East Boulevard.

Gus Thomasson Road, east side, from the north right-of-way line of U.S. Highway 80 to a point seventy-seven feet northwesterly.

Gus Thomasson Road, east side, from the northwesterly. to the southwesterly property line of the Macedoia Baptist Church, such distance being one hundred feet.

Gus Thomasson Road, east side, from the south rightof-way line of Tripp Road to a point two hundred feet south.

Gus Thomasson Road, east side, from the south side of Ridgeview Street, extended, to a point three hundred feet south.

Gus Thomasson Road, west side, from Rustown Drive extension to South Mesquite Creek.

Gus Thomasson Road, west side from the north side of Antilles Drive, extended, south to the north side of Caribbean Drive, extended.

Gus Thomasson Road from Belt Line Wye to U.S. Highway 80.

Gus Thomasson Road, from U.S. Highway 57 to the north corporate limits of the city.

Gus Thomasson Road, east side, from one thousand feet north of Rustown Extension to South Mesquite Creek.

U.S. 80 North Service Rd., both sides, from North Galloway westerly to Gus Thomasson Road.

 To the list of designated streets in Section 10-61.2 the following is added:

East Meadows Boulevard, both sides, from U.S. Highway 80 to I.H. 30.

Gus Thomasson Rd., both sides, from U.S. Highway 80 to North City Limit.

U.S. Highway 80 North Service Road, both sides, from North Galloway westerly to Franklin Drive.

North Mesquite Drive, both sides, from Towne Centre Drive to Gus Thomasson Road

Franklin Drive, both sides, from U.S. Highway 80 northwest to Towne Centre Drive.

North Galloway Avenue, both sides, from Grubb Dr. to U.S. Highway 80.

SECTION 2. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 4. Whereas, the fact that the ordinances of the City of Mesquite do not presently adequately provide for the regulation of parking as described in Section 1 of this ordinance to protect the public interest, confort, and general welfare of the City of Mesquite, creates an urgency and emergency for the preservation of the public health, safety and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provide.
