ORDINANCE NO. 2139

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER X, SECTION 10-47.5 OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING CERTAIN LANGUAGE, THEREBY CHANGING THE DESIGNATION FOR THE SCHOOL ZONE ON PIONEER ROAD FOR RUTHERFORD ELEMENTARY SCHOOL; AND CHANGING THE HOURS DURING WHICH ALL DESIGNATED SCHOOL ZONES SHALL BE IN EFFECT FROM THE PRESENT 7:30 A.M. TO 9:00 A.M. AND FROM 2:00 P.M. TO 4:00 P.M., TO 7:30 A.M. TO 9:00 A.M. AND FROM 2:30 P.M. TO 4:30 P.M.; AND AMENDING CHAPTER X, SECTION 10-47.8 OF THE CODE OF THE CITY OF MESQUITE BY ADDING CERTAIN LAN-GUAGE, AND DELETING CERTAIN PRESENT LANGUAGE, THEREBY CHANGING THE DESIGNATION OF SPEED ZONES ON NORTH GALLOWAY AVENUE AND DESIGNATING SPEED LIMITS ON FRANKLIN DRIVE AND NORTH MES-QUITE DRIVE, BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE, AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter X, Section 10-47.5 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X Section 10-47.5 of the Code of the City of Mesquite:

The following streets and portions thereof are hereby designated as school zones for the schools indicated from 7:30 a.m. to 9:00 a.m. and from 2:00 p.m. to 4:00 p.m. and said streets and portions thereof are hereby zoned for a maximum of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent.

LOCATION OF SCHOOL ZONE

Rutherford

Pioneer Road from 200 feet morth to 200 feet south of its intersection with Sierra Drive 50232

The following language shall be added to Chapter X Section 10-47.5 of the Code of the City of Mesquite:

The following streets and portions thereof are hereby designated as school zones for the schools indicated from 7:30 a.m. to 9:00 a.m. and from 2:30 p.m. to 4:30 P.M., and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent.


Pioneer Road from 20 feet south of the south curb line of Leyenda to 250 feet south of the south curb line of Sierra Drive

SECTION 2. Chapter X, Section 10-47.8 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X, Section 10-47.5 of the Code of the City of Mesquite:

North Galloway Avenue	From Tripp Drive North to Town East Boulevard	45	
North Galloway Avenue	From Grubb Drive North to Tripp Road	35	
The following language shall be added to Chapter X, Section 10-47.8 of the Code of the City of Mesquite:			

STREET	EXTENT	SPEED (MPH)
Franklin Drive	From U.S. Highway 80 to Towne Centre Drive	35
North Mesquite Drive	From Towne Centre Drive to Gus Thomasson Road	35
North Galloway Avenue	From Courtney Drive North to Town East Boulevard	45
North Galloway Avenue	From Grubb Drive North to Courtney Drive	35



SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 4. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 5. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City creates an urgency and emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides
