

ORDINANCE NO. 2166

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 10, SECTION 10-33.11 OF THE CODE OF THE CITY OF MESQUITE, TEXAS, THEREBY ADOPTING THE 1980 TEXAS MANUAL ON UNIFORM TRAFFIC-CONTROL DEVICES; PROVIDING THAT SAME SHALL BE THE OFFICIAL TRAFFIC-CONTROL MANUAL FOR THE CITY OF MESQUITE; PROVIDING THAT TRAFFIC CONTROL-DEVICES PLACED OR INSTALLED BY THE CITY SHALL REMAIN OFFICIAL TRAFFIC CONTROL-DEVICES OF THE CITY UNTIL CHANGED; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00); PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the 1980 Texas Manual on Uniform Traffic-Control Devices be, and the same is, hereby adopted by the City of Mesquite as the official Traffic-Control Manual for the City of Mesquite together with any revisions and amendments thereto, except where same shall be in conflict with the State Law. Provided, however, that any Traffic-Control Device in use or placed in use by the City of Mesquite shall remain an official Traffic-Control Device until such time as same shall be changed to conform with said 1980 Manual.

SECTION 2. All Traffic-Control Devices placed or installed in accordance with said Manual shall be official Traffic-Control Devices of the City of Mesquite. Any person who shall disobey or disregard the instructions or requirements of any such Traffic-Control Device shall be guilty of a misdemeanor and upon conviction shall be subject to a fine not to exceed Two Hundred Dollars (\$200.00).


SECTION 3. That all ordinances of the City of Mesquite in conflict with the provisions of this ordinance be, and the same are, hereby repealed to the extent of such conflict and ordinances not in conflict herewith shall remain in full force and effect.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 5. The fact that uniformity of Traffic-Control Devices is necessary to the public welfare and safety creates an urgency and an emergency in the interest of the public health, safety and welfare and necessitates that this ordinance become effective immediately from and after its date of passage as the law in such cases provides.


