

ORDINANCE NO. 2234

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 10, SECTION 47.5, OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN EXISTING SCHOOL ZONES; BY ESTABLISHING CERTAIN NEW SCHOOL ZONES; BY PROVIDING THE LOCATION AND TIME OF SAID SCHOOL ZONES AND ESTABLISHING THE MAXIMUM PRIMA FACIE SPEED LIMIT DURING SUCH PERIOD TO BE TWENTY (20) MILES PER HOUR; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 10, Section 47.5 of the Code of the City of Mesquite is amended as follows, in all other respects to remain in full force and effect:

The following streets and portions thereof are hereby designated as school zones for the school indicated from 7:30 A.M. to 9:00 A.M. and from 2:30 P.M. to 4:30 P.M. and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent:

1. To the list of designated streets in Section 10-47.5 the following are deleted:

McKenzie Elementary	Emerald from Kensington Drive to 250 feet south of Stephens Green Drive Stephens Green Drive from Emerald Drive to Concord Drive
Beasley Elementary	North Galloway Avenue from Brownfield Drive to Devonshire North Galloway Avenue from the alley south of Meandering Way to 220 feet north of Devonshire
Motley Elementary	Hyde Park from Sidney to Moon Moon from Hyde Park to Motley Drive

2. To the list of designated streets in Section 10-47.5 the following are added:



McKenzie Elementary	Emerald Drive from 50 feet NE of Kensington Drive to 50 feet SW of Stephens Green Drive
	Stephens Green Drive from 50 feet NW of Concord Drive to Emerald Drive
	Concord Drive from 50 feet SW of Stephens Green Drive to Kensington Drive
Tosch Elementary	Gus Thomasson from 200 feet north of Motley to US 80 NSR access ramp
	Rustown from 50 feet north of Larchmont to Apollo Way
Motley Elementary	Hyde Park from 50 feet south of Sidney to 40 feet south of Moon Drive

SECTION 2. That should any paragraph, sentence, subdivision, clause phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred Dollars (\$200.00) for each offense.

SECTION 4. That the ordinances of the City of Mesquite are inadequate to control the rate of speed of vehicles around certain public schools creates an urgency and emergency and in the preservation of the public health, safety and welfare requires that this ordinances shall become effective immediately from and after its passage and the publication of caption, as the law and in such cases provides.
