AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, PROVIDING FOR THE ABANDONING OF EXCESS RIGHT-OF-WAY ON LOT 2, BLOCK 2 OF THE TRIANGLE EAST ADDITION; CITY OF MESQUITE, DALLAS COUNTY, TEXAS, AS DESCRIBED IN EXHIBIT "A" HERETO AND AUTHORIZING THE MAYOR TO EXECUTE A QUITCLAIM DEED TO MLM PROPERTIES; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the portion of the excess right-of-way on Lot 2, Block 2 of the Triangle East Addition, City of Mesquite, Dallas County, Texas, as described in Exhibit "A" attached hereto, shall be, and the same is hereby abandoned.

SECTION 2. That Mayor Brunhilde Nystrom is hereby authorized to execute a Quitclaim Deed to effect such abandonment to MLM Properties.

SECTION 3. The fact that the orderly development of the City of Mesquite requires that the excess right-of-way be abandoned creates an urgency and an emergency and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of its caption as the law in such cases provides.


