

ORDINANCE NO. 2264

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER 14A, CODE OF THE CITY OF MESQUITE BY ADOPTING THE 1985 EDITION OF THE UNIFORM PLUMBING CODE WITH CERTAIN AMENDMENTS AND DELETIONS AND PROVIDING AN EFFECTIVE DATE FOR APPLICATION OF THE CODE TO WORK PERMITTED AFTER SUCH DATE; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 14A, Code of the City of Mesquite, Texas is hereby amended effective January 1, 1986 as follows, in all other respects to remain in full force and effect:

A. Section 14A-1 is hereby amended by changing the phrase, Uniform Plumbing Code, "1982" Edition to Uniform Plumbing Code "1985" Edition.

B. Section 14A-1.1, Amendments and Deletions is hereby amended as follows:

(a) Deletions

Section 20.3 (first sentence)

Section 20.7 is deleted in its entirety including the Schedule Of Fees (p. 4a)

Section 20.14 is deleted in its entirety.

Items from Table A, "Plumbing Material Standards" (pp. 21-28) (to be deleted):

Polyethylene pipe and fittings for water
 Homogenous bituminized fiber drain and sewer pipe
 PVC material gas yard piping
 PVC pipe and fittings with rubber gasket joints for cold water
 Copper and copper alloy welded water tubes (installation)
 Welded copper-alloy water tubes
 Welded copper-alloy GNS No. C21000 Water Tube
 Chlorinated poly vinyl chloride (CPVC) plastic pipe schedules 40 and 80
 Chlorinated poly vinyl chloride (CPVC) plastic hot water distribution systems
 Polyethylene (PE) cold water buildings supply and yard piping and tubing (installation)
 Polyethylene (PE) plastic pipe (SDR-PR)

Socket Type chlorinated poly vinyl chloride (CPVC) plastic pipe fittings Schedule 40 & 80
 Solvent cements for chlorinated poly vinyl chloride (CPVC) plastic pipe and fittings
 Plastic bathtub units
 Plastic shower receptors and shower stalls
 Plastic lavatories
 Thermoplastic gas pressure pipe, tubing and fittings

(b) Amendments

Section 20.2 (b) and (c) are amended by adding to each the language "to extent the foregoing is permitted under the State and Federal Constitutions".

Items from Table 7-1, Horizontal Distance of Trap Arms (p. 56) is amended to read:

<u>Trap Arm Inches</u>	<u>Distance Trap to Vent</u>
1 1/4	5 feet
1 1/2	5 feet
3	6 feet
4	10 feet

(Slope 1/4" per foot)

(c) PVC Pipe Primer: (Is amended to read as follows) In all cases where PVC pipe is used, a colored primer is required.

(d) Effect of Code. (Is amended to read as follows) Work permitted prior to the effective date of this code (January 1, 1986) shall be completed under the current Mesquite Plumbing Code. Work permitted after the effective date of the adoption of this code, shall be performed pursuant to this code; however, the existing schedule of fees and charges shall remain in effect until repealed, amended or modified.

SECTION 2. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact that the present ordinances of the City of Mesquite are inadequate to protect the health and welfare of the inhabitants of the City of Mesquite creates an urgency and an emergency and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of its caption as the law in such cases provides.
