## ORDINANCE NO. 2341

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS
LEVYING, THE AD VALOREM TAXES FOR THE YEAR
1986 AT A RATE OF \$ 0.51 PER ONE HUNDRED
DOLLARS (\$100.00) ASSESSED VALUATION OF ALL
TAXABLE PROPERTY WITHIN THE CORPORATE
LIMITS OF THE CITY OF MESQUITE AS OF
JANUARY 1, 1986, TO PROVIDE REVENUE FOR THE
PAYMENT OF CURRENT EXPENSES AND INTEREST
AND SINKING FUND REQUIREMENTS; PROVIDING
FOR DUE AND DELINQUENT DATES TOGETHER WITH
PENALTIES AND INTEREST; PROVIDING FOR PLACE
OF PAYMENT; APPROVING THE 1986 TAX ROLLS
AND ANY SUPPLEMENT THERETO; PROVIDING
CERTAIN EXEMPTIONS AND DECLARING AN
EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That there be and is, hereby levied for the year 1986 on all taxable property, real, personal, and mixed, situated within the corporate limits, of the City of Mesquite, and not exempt by the Constitution of the State and valid State Laws, a tax of  $\frac{50.51}{100}$  on each One Hundred Dollars (\$100.00) assessed valuation of taxable property, with a ratio of  $\frac{1008}{100}$  of the market value, and shall be apportioned and distributed as follows:

For the purpose of defraying the current operating expenses of the municipal government a tax of \$.2873 and for interest and sinking fund of the municipal government a tax of \$.2227 on each One Hundred (\$100.00) Dollars assessed value of taxable property, with a ratio of 100% of the market value.

SECTION 2. Provided, however, that there is hereby adopted an exemption to ad valorem taxation in the amount of fifteen

Thousand Dollars (\$ 15,000.00 ) on the residence homestead of individuals over the age of sixty-five (65) years of age, said "residence homestead" being as defined in Section 11.13(j) of the Property Tax Code adopted by the 66th Legislature.

SECTION 3. That all ad valorem taxes shall become due and payable on October 1, 1986, and all ad valorem taxes for the year 1986 shall become delinquent after January 31, 1987. If any person fails to pay the ad valorem taxes on or before the 31st day of January, 1987, the following penalties shall be payable thereon, to wit: During the month of February, seven (7%) per cent and two (2%) per cent for each additional month prior to July 1st of the year it becomes delinquent.

SECTION 4. Taxes are payable in Mesquite, Texas, at the Municipal Building. The City shall have available all the rights and remedies provided by law for the enforcement of the collection of taxes levied under this Ordinance. 

SECTION 5. That the 1986 tax rolls, as presented to the City Council, together with any supplement thereto, be, and the same are, hereby approved.

SECTION 6. All delinquent tax accrues interest at a rate of one per cent for each month or portion of a month the tax remains unpaid.

SECTION 7. The fact that it is necessary that this ordinance be enacted in order to authorize the collection of ad valorem taxes for the 1985 and prior to a public hearing as required by law creates an urgency and an emergency and requires that this ordinance shall take effect immediately from and after its passage as the law in such cases provides, subject, as aforesaid, to said public hearing.
