

ORDINANCE NO. 2348

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER X OF THE CODE OF THE CITY OF MESQUITE, TEXAS BY ADDING CERTAIN LANGUAGE TO SECTION 10-33.12(2) THEREBY PROHIBITING U-TURNS ON NORTH BOUND N. GALLOWAY AVENUE AT TRIPP ROAD; AND BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING CERTAIN NEW LANGUAGE TO SECTION 10-33.12 THEREBY DELETING CERTAIN PRESENT SCHOOL ZONES FOR MCDONALD SCHOOL AND DESIGNATING A SCHOOL ZONE FOR SHANDS SCHOOL; AND BY DELETING CERTAIN LANGUAGE FROM SECTION 10-61.2 THEREBY ELIMINATING CERTAIN NO PARKING RESTRICTIONS ON HILLCREST STREET; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter X, Section 10-33.12(2) of the Code of the City of Mesquite is hereby amended as follows in all other respects to remain in full force and effect:

The following language shall be added to the Section 10-33.12(2) of the Code of the City of Mesquite, which prohibits U-Turns:

N. Galloway at Tripp Road, Northbound

SECTION 2. Chapter X, Section 10-47.5 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X, Section 10-47.5 of the Code of the City of Mesquite which designates school zones:

School

Location of School Zone

McDonald

Town East eastbound from 124 feet east of east curb of Eastridge to 100 feet east of east curb of Edgebrook

Town East westbound from 100 feet east of east curb of Edgebrook to 124 feet east of east curb of Eastridge

On Town East from John Glen Parkway
to 100 feet east of Edgebrook

The following language shall be added to Chapter X, Section 10-47.5 of the Code of the City of Mesquite, which designates school zones:

<u>School</u>	<u>Location of School Zone</u>
Shands	N. Galloway from 250 feet south of Karla Drive to 250 feet north of Karla Drive

Section 3. Chapter X, Section 10.61.2 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X, Section 10-61.2 of the Code of the City of Mesquite which designates locations where parking of vehicles is prohibited:

Hillcrest Street, south side, from a point even with the east curb line of Hillcrest Community Center parking lot to the west curb line of the easterlymost drive of the Hillcrest Swimming Pool parking lot.

SECTION 4. That should any paragraph, sentence, subdivision, clause phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 5. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of 1973, of the City of Mesquite, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 6. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City creates an urgency and emergency for the preservation of the public health, safety and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance as the law in such cases provides.
