ORDINANCE NO. 2429

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER 10 SECTION 10-67 OF THE CODE OF THE CITY OF MESQUITE BY ADDING A NEW SECTION 10-67 (c) PROHIBITING OPERATION OF COMMERCIAL VEHICLES ON CERTAIN DESIGNATED STREETS; BY PROVIDING A SEVERABILITY CLAUSE; BY PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 10 Section 10-67 of the Code of the City of Mesquite is amended by adding a section (c) as follows, in all other respects to remain in full force an effect:

(c) Commercial Vehicles Prohibited from Using Certain Streets.
When signs are erected giving notice thereof, no person shall operate a commercial vehicle at any time upon any of the following streets or parts of streets, except that such vehicles may be operated thereon for the purpose of delivering or picking up materials or merchandise and then only by entering such street at the intersection nearest the destination of the vehicle and proceeding thereafter no further than the nearest intersection thereafter:

SECTION 2. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor, and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 4. Whereas, the fact that the ordinances of the City of Mesquite do not presently provide for the regulation of traffic as described in Section 1 of this ordinance to protect the public interest, comfort, and general welfare of the City of Mesquite, creates an urgency and emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
