ORDINANCE NO. 2495

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER X, SECTION 10-61.2 OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING CERTAIN LANGUAGE THEREBY PROVIDING THAT WHEN NOTICE IS GIVEN BY THE POSTING OF SIGNS OR MARKING OF CURBS, PARKING AND STANDING OF VEHICLES SHALL BE PROHIBITED ON CERTAIN DESIGNATED STREETS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter X, Section 10-61.2 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

- When signs are erected or curbs marked giving notice to such effect, no person shall park or leave standing a vehicle at any time upon the portions of the streets described below.
- 1. To the list of designated streets in Section 10-61.2 the following is added:

Belt Line Road, both sides, from north city limits to a point 250 feet south of Bluffview Drive.

Belt Line Road, both sides, from Range Drive to Galloway Avenue.

Belt Line Road, both sides, from New Market Road to south city limits.

Bruton Road, both sides, from Hickory Tree Road to Pioneer Road.

Bryan-Belt Line Road, both sides, from Belt Line Road to Holley Street.

East Glen Boulevard, both sides, from Pioneer Road to Berry Road.

North Galloway Avenue, both sides, from La Prada Drive to Main Street.

South Galloway Avenue, both sides, from Main Street to Belt Line Road.

Gross Road, both sides, from U.S. Highway 80 to Kearney Street.

La Prada Drive, both sides, from west city limits to east city limits.

Military Parkway, both sides, from Sam Houston Road to Carmack Street.

Motley Drive, both sides, from Interstate Highway 30 to Town East Boulevard.

Northwest Drive, both sides, from La Prada Drive to Belt Line Road.

Oates Drive, both sides, from west city limits to east city limits.

Peachtree Road, both sides, from Gross Road to Scyene Road

Samuell Boulevard, both sides, from west city limits to Town East Boulevard.

Scyene Road, both sides, from Sam Houston Road to east city limits.

Skyline Drive, both sides, from Town East Boulevard to Peachtree Road.

Town East Boulevard, both sides, from Sam Houston Road to east city limits.

To the list of designated streets in Section 10-61.2 the following is deleted:

La Prada Drive, south side, from the west property line of the church property to a point two hundred forty feet east.

North Galloway Avenue, both sides, from Grubb Drive to U.S. Highway 80.

North Galloway Avenue, east side, from the north side of W. McKinney Street, extended to the north side of Kimbrough Street and the north side of E. Kimbrough street from the east of N. Galloway Avenue East to the east side of Bryan Street right-of-way and on the east side of N. Seaton from East Texas to E. Kimbrough Street and, on the south side of E. Kimbrough Street from the east side of N. Seaton Street to the east side of Bryan Street right-of-way.

North Galloway, from the Texas & Pacific Railroad right-of-way to Belt Line Wye.

South Galloway Avenue, east side from the north side of the cemetery to a point two hundred seventy-five feet north.

South Galloway Avenue, east and west sides, from the Texas and Pacific Railroad to the south line of New Market Street.

South Galloway Avenue, both sides, from College Street to Texas Street.

SECTION 2. That should any paragraph, sentence, subdivision, clause phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-61.2 any other provision of the Code of the City of Mesquite.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact the the present ordinances of the City of Mesquite do not adequately protect the safety of the shabitants of the City creates an urgency and emergency and in the preservation of the safety and welfare requires that this ordinance shall become effective immediately and after its passage and the publication of caption, as the law and in such cases provides.
