

ORDINANCE NO. 2572

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER 10, SECTION 10-47.8 OF THE CODE OF THE CITY OF MESQUITE BY ADDING CERTAIN LANGUAGE THEREBY CREATING A FORTY (40) MPH SPEED ZONE ON GROSS ROAD FROM MOTLEY DRIVE TO JANE STREET; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter 11, Section 10-47.8 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter 10, Section 10-47.8 of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED</u>
Gus Thomasson Road	From U.S. Hwy. 80 to 300 feet south of North Mesquite Drive	45
Gross Road	From U.S. Hwy. 80 to 100 feet south of Jane Street	45
Gross Road	From a point 100 feet south of its intersection with Jane Street to its intersection with Chappell	40

The following language shall be added to Chapter 10 Section 10-47.8 of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED</u>
Gus Thomasson Road	From a point 300 feet south of North Mesquite Drive to Motley Drive	45
Gus Thomasson Road	From Motley Drive to U.S. Highway 80	40
Gross Road	From U.S. Highway 80 to Chappell Drive	40


SECTION 2. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this


ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City creates an urgency and emergency and in the preservation of the public health, safety and welfare requires that this ordinance shall become effective immediately from and after its passage and the publication of caption, as the law in such cases provides.


