ORDINANCE NO. 2594

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING ORDINANCE NO. 2567 OF THE CITY OF MESQUITE, TEXAS, THE CITY OF MESQUITE SIGN ORDINANCE; BY ADDING A DEFINITION FOR BILLBOARD SIGN TO SECTION II, AND ADDING NEW PROVISIONS TO SECTION V RELATING TO BILLBOARD SIGN LOCATIONS AND SPECIFICATIONS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Ordinance No. 2567 of the City of Mesquite, The City of Mesquite Sign Ordinance, is hereby amended by adding a definition for Billboard sign to Section II, and adding provisions relating to location and specifications for Billboard signs to Section V as follows, the remaining portions of said sections and ordinance to remain in full force and effect:

Section II - Definitions. To the list of definitions in Section II, the following is added:

Billboard Sign: A sign adjacent to freeways and used for the purpose of off premise advertising and conveyance of messages, utilizing a monopole pylon type sign structure.

Section V - Sign Specifications. To the sign specifications contained in Section V the following is added:

Billboard signs - Purpose and Location:

For the purpose of off premise advertising and conveyance of messages, billboards utilizing a monopole pylon type sign structure shall be permitted in the following locations, erection or maintenance of a billboard structure at a location other than specifically permitted herein is prohibited:

Permitted Locations:

- 1. 1500 Hwy. 80, Mcsquite, Dallas County, Texas, said location being more particularly described in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.
- 2. 1300 Hwy. 80, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "B", attached hereto and made a part of this ordinance for all purposes.
- 3. 600 Hwy. 80, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "C", attached hereto and made a part of this ordinance for all purposes.
- 4. 15300 I.H. 635, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "D", attached hereto and made a part of this ordinance for all purposes.
- 15999 I.H. 635, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "E", attached hereto and made a part of this ordinance for all purposes.
- 6. 4610 Hwy. 67, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "F", attached hereto and made a part of this ordinance for all purposes.
- 7. 4030 Hwy. 67, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "G", attached hereto and made a part of this ordinance for all purposes.

- 8. 18901 I.H. 635, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "H", attached hereto and made a part of this ordinance for all purposes.
- 9. 3001 Hwy. 80, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "I" attached hereto and made a part of this ordinance for all purposes.
- 10. 22000 I.H. 635, Mesquite, Dallas County, Texas, said location being more particularly described in Exhibit "J", attached hereto and made a part of this ordinance for all purposes.

Specifications:

- All signs must conform to the licensing and zoning regulations of the Texas Highway Beautification
 Act.
- 2. No sign shall exceed 400 square feet in size for each face.
- 3. No sign shall exceed 42½ feet in height as measured from the highest point of the sign to the grade level of the highway from which the sign is to be viewed.
- No sign shall be located within 1500 feet of any other billboard sign on the same side of the highway.
- 5. Signs shall be set back a minimum of five (5) feet from all property lines.
- Signs shall be of all steel single pylon construction. Design and specifications shall bear the seal of a licensed Professional Engineer in the State of Texas.
- 7. The initial permit fee to cover administrative processing and cost of inspection shall be \$100.00.
- 8. Billboards shall be allowed only at those locations described herein. Signs existing in the described locations on the date this Ordinance is passed shall be removed or converted to meet the specifications described herein within 120 days from the effective date of this Ordinance.
- 9. There shall be no procedure for obtaining a permit to crect or maintain a Billboard in any location other than those locations described herein.
- SECTION 2. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional the remaining provisions of this ordinance shall remain in full force and effect.
- SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Five Hundred (\$500.00) Dollars for each offense.
- SECTION 4. That the present ordinances of the City of Mesquite are inadequate to properly regulate Billboard Signs within the City of Mesquite, creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
