

ORDINANCE 2615

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER X, SECTION 10-47.8 OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING CERTAIN LANGUAGE THEREBY CHANGING CERTAIN SPEED ZONE LOCATIONS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Chapter X, Section 10-47.8 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Chapter X, Section 10-47.8 of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED (MPH)</u>
Berry Drive	From its intersection with Scylene Road to its intersection with Lawson Road	45
Cartwright Road	From its intersection with Windsor Drive to its intersection with Lawson Road	45
Church Road	From its intersection with Berry Road to its intersection with Edwards Road	45
Edwards Road	From its intersection with Cartwright Road to its intersection with Church Road	45
Lawson Road	From the east city limit to its intersection with Cartwright Road	45
Mathis Road	From its intersection with Edwards Road to its intersection with Lawson Road	45
Mesquite Valley Road	From its intersection with Eulane Drive to its intersection with Berry Road	45
Scylene Road	From its intersection with State Highway 352 to the east city limit	45

The following language shall be added to Chapter X, Section 10-47.8 of the Code of the City of Mesquite:

<u>STREET</u>	<u>EXTENT</u>	<u>SPEED (MPH)</u>
Berry Road	From Lawson Road to Scylene Road	35
Cartwright Road	From Pioneer Road to Lawson Road	35
Clay-Mathis Road	From north city limit to Edwards Church Road	45



Clay-Mathis Road	From Edwards Church Road to Lawson Road	35
Creek Crossing	From Clay-Mathis Road to Berry Road	35
Creek Valley	From Newsom Road to Faithon P. Lucas Sr. Boulevard	35
Edwards Church Road	From Cartwright Road to Clay-Mathis Road	30
Edwards Church Road	From Clay-Mathis Road to Berry Road	35
Lawson Road	From north city limit to south city limit	35
Faithon P. Lucas Sr. Boulevard	From Berry Road to Cartwright Road	45
Faithon P. Lucas Sr. Boulevard	From Cartwright Road to south city limit	35
Mesquite Valley Road	From Eulane Road to Clay-Mathis Road	35
Scyene Road	From State Highway 352 to east city limit	35

SECTION 2. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Article 10-47.8, or any other provision of the Code of the City of Mesquite.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City creates an urgency and emergency and in the preservation of the public health, safety and welfare requires that this ordinance shall become effective immediately from and after its passage and the publication of caption, as the law in such cases provides.
