ORDINANCE NO. 2878

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 9-199 OF THE CODE OF THE CITY OF MESQUITE BY DELETING CERTAIN PRESENT LANGUAGE AND ADDING CERTAIN LANGUAGE THEREBY PROVIDING THAT WHEN NOTICE IS GIVEN BY THE POSTING OF SIGNS OR MARKING OF CURBS, IT SHALL BE UNLAWFUL TO PARK OR STAND A VEHICLE FOR A PERIOD OF MORE THAN TWO (2) HOURS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 9-199 of the Code of the City of Mesquite is hereby amended as follows, in all other respects to remain in full force and effect:

When notice is given by the erection of signs or the marking of curbs to such effect, it shall be unlawful to park or stand a vehicle for a period of more than two (2) hours on the following streets or portions thereof.

1. To the list of designated streets in Section 9-199 the following is added:

<i>Street</i>	<i>Extent</i>	<i>Time</i>
Broad	West side (far west parking lane on Heritage Square) from Main Street to Davis Street	Anytime
West Main	South side from Broad to Ebrite	Anytime
West Main	North side from Broad to Ebrite	7:00 a.m. to 6:00 p.m. Monday through Saturday

2. To the list of designated streets in Section 9-199 the following is deleted:

<i>Street</i>	<i>Extent</i>	<i>Time</i>
Broad	West side (far west parking lane on Heritage Square) from Main Street to Davis Street	7:00 a.m. to 6:00p.m. Monday through Saturday



**SECTION 2.** That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Section 9-199 or any other provision of the Code of the City of Mesquite.


**SECTION 3.** That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

**SECTION 4.** The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City, creates an urgency and emergency and in the preservation of the public health, safety and welfare requires that this ordinance shall become effective immediately from and after its passage and the publication of its caption, as the law and in such cases provides.
