AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, PROVIDING FOR THE ABANDONMENT OF AN UNNAMED STREET RIGHT-OF-WAY THAT IS ADJACENT TO AND WEST OF 1422 E. HIGHWAY 80 SITUATED IN DALLAS COUNTY, TEXAS AS RECORDED IN VOLUME 4173, PAGE 348 DEED RECORDS OF DALLAS COUNTY, TEXAS; AUTHORIZING THE MAYOR TO EXECUTE A QUIT CLAIM DEED TO SKIP WISDOM; PROVIDING AN EFFECTIVE DATE THEREOF; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Mesquite was heretofore dedicated street right-of-way that has never been improved with paving or used for access;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City of Mesquite does hereby release and abandon the unnamed street right-of-way that is located adjacent to and west of 1422 E. Highway 80 described in Exhibit "A" attached hereto and included herein for all purposes.

SECTION 2. That Mayor Cathye Ray is hereby authorized to execute a Quit Claim Deed to carry out said abandonment.

SECTION 3. That said dedicated unnamed street right-of-way is not needed for public purposes and it is the public interest to abandon said described street right-of-way and the same is hereby abandoned, vacated and closed insofar as the public is concerned.

SECTION 4. That the orderly development of the City of Mesquite requires the release and abandonment of the unnamed street right-of-way described herein, creates an urgency and emergency in the public interest and necessitates that this ordinance become effective immediately from and after its date of publication of the caption as the law in such cases provides.


