

ORDINANCE NO. 2918

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS
ESTABLISHING A SCHEDULE OF CHARGES FOR VARIOUS
RECREATION SERVICES TO BE EFFECTIVE FROM AND AFTER
OCTOBER 1, 1993; BY PROVIDING FOR A SEVERABILITY
CLAUSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF MESQUITE, TEXAS:

SECTION 1. That an ordinance establishing charges for various recreation
services to be effective from and after October 1, 1993 be adopted to read as follows:

SCHEDULE OF CHARGES
FOR RECREATION SERVICES

1. User Fees: Payable by both residents and non-residents
 - a. Per individual per community center class \$1.00
 - Per individual per sport season \$2.00
 - Per individual for track/swim team \$5.00
 - b. Non-resident Fees:

Youth (17 and under)	\$10.00
Adult	\$10.00
Family Card	\$40.00

2. Reservations:

Gymnasium (1/2 gym during operational hours)	\$10.00/hr.
Gymnasium (entire gym, outside operational hours)	\$25.00/hr.

Athletic Field Rentals (use of lights)	\$10.00/1-1/2 hrs.
Athletic Field Rentals (during daylight hrs.)	\$ 5.00/1-1/2 hrs.



SECTION 3. The fact that the City of Mesquite has no adequate ordinance regulating charges for Recreation Services creates an urgency and an emergency and requires that this ordinance shall take effect immediately from and after its passage and publication as the law in such cases provides.
