

ORDINANCE NO. 2931

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING SECTION 9-147 OF THE CODE OF THE CITY OF MESQUITE BY AMENDING SCHOOL ZONE TIMES FOR CERTAIN LOCATIONS; PROVIDING THE LOCATION OF SAID SCHOOL ZONE AND MAINTAINING THE MAXIMUM PRIMA FACIE SPEED LIMIT DURING SUCH PERIOD TO BE TWENTY (20) MILES PER HOUR; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 9-147 of the Code of the City of Mesquite is hereby amended by amending school zone times for certain locations, in all other respects to remain in full force and effect:

The following streets and portions thereof are hereby designated as school zones for the school indicated from 7:00 A.M. to 8:15 A.M. and from 2:30 P.M. to 3:30 P.M. and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent:

The following language shall be deleted from Section 9-147(1) of the Code of the City of Mesquite:

SCHOOL

LOCATION OF SCHOOL ZONE

Shaw

Purple Sage Trail from 250 feet south of Wildflower Lane to 400 feet north of Wildflower Lane

The following streets and portions thereof are hereby designated as school zones for the school indicated from 7:45 A.M. to 8:45 A.M. and from 2:30 P.M. to 4:00 P.M. and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent:

The following language shall be deleted from Section 9-147(2) of the Code of the City of Mesquite:

Kimbell	Brazoria Drive from 250 west of Coryell Way to 250 feet east of Pecos Drive
Lawrence	Oates Drive westbound from 100 feet west of San Marcus to 100 feet east of Scottsdale Oates Drive east bound from 150 feet west of Sherwood to 300 feet east of Modlin Statler Drive from Modlin Drive to Rickman Drive Rickman Drive from Statler Drive to Rockne Lane Modlin Street from Hilton Drive to Statler Drive

The following streets and portions thereof are hereby designated as school zones for the school indicated from 7:00 A.M. to 8:15 A.M. and from 2:30 P.M. to 3:30 P.M. and said streets and portions thereof are hereby zoned for a maximum speed of twenty (20) miles per hour during such times. Any speed in excess of said maximum shall be prima facie unreasonable and imprudent:

The following language shall be added to Section 9-147(1) of the Code of the City of Mesquite:

Kimbell	Brazoria Drive from 250 feet west of Coryell Way to 250 feet east of Pecos Drive Coryell Way from 100 feet south of Panola to Brazoria Uvalde Street from Coryell Way to 500 feet east of Coryell Way
Lawrence	Statler Drive from Modlin Drive to Rickman Drive Rickman Drive from Statler Drive to Rockne Lane Modlin Street from Hilton Drive to Statler Drive


McWhorter	McWhorter Drive from Hickory Tree Road to 300 feet west of Savage Drive
Shaw	Purple Sage Trail from 250 feet south of Wildflower Lane to Juniper Lane Juniper Lane from Snapdragon Trail to Wildflower Lane


SECTION 2. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Section 9-147, or any other provision of the Code of the City of Mesquite.


SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City, creates an urgency and in the preservation of the public health, safety and welfare requires that this ordinance shall become effective immediately from and after its passage and the publication of caption, as the law in such cases provides.
