ORDINANCE NO. 3029

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, PROVIDING THE ABANDONMENT OF A UTILITY EASEMENT SITUATED IN DALLAS COUNTY, TEXAS AND BEING A PORTION OF WEST MESQUITE HIGH SCHOOL, AN ADDITION TO THE CITY OF MESQUITE, DALLAS COUNTY, TEXAS AS RECORDED IN VOLUME 91219, PAGE 1454 PLAT RECORDS OF DALLAS COUNTY, TEXAS; DECLARING AN EMERGENCY; AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City of Mesquite has heretofore obtained a utility easement that will not be needed in the future;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That a portion of West Mesquite High School Addition more particularly described in Exhibit "A" attached hereto and included herein for all purposes shall be, and the same is hereby abandoned.

SECTION 2. That said utility easement is not needed for public purposes and it is the public interest of the City of Mesquite to abandon said described easement and the same is hereby abandoned, vacated and closed insofar as the right, title or easement of the public is concerned.

SECTION 3. That the orderly development of the City of Mesquite requires the release and abandonment of the easement described herein creates an urgency and emergency in the public interest and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of the caption as the law in such cases provides.

20 FOOT UTILITY EASEMENT ABANDONMENT

THENCE S 43°20'43" W a distance of 1858.17 feet to a point in the south line of Memorial Boulevard (80 foot wide), said point being N 88°44'00" E a distance of 240.00 feet, along said south line of Memorial Boulevard from the intersection of said south line and east line of Brunswick Lane;

THENCE S 01°16'00" E, leaving said south line and along the east line of said 20 foor Utility Easement, a distance of 60.99 feet to the POINT OF BEGINNING;

THENCE S 01°16'00" E continuing along said east line a distance of 74.01 feet to a point for corner;

THENCE N 88°44'00" E a distance of 20.00 feet to a point for corner;

THENCE S 01°16'00" E a distance of 20.00 feet to a point for corner;

THENCE S 88°44'00" W a distance of 20.00 feet to a point for corner;


THENCE S 01°16'00" E a distance of 46.87 feet to a point for corner,


THENCE S 88°44'00" W a distance of 20.00 feet to a point for corner in the west line of said 20 foot easement;
