AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ABANDONING THE RIGHT-OF-WAY FOR EASTFIELD PLAZA FROM I.H. 30 TO EASTFIELD BOULEVARD AND FOR EASTFIELD BOULEVARD FROM EASTFIELD PLAZA TO I.H. 30 SITUATED IN DALLAS COUNTY, TEXAS AND BEING A PORTION OF EASTFIELD PLAZA AN ADDITION TO THE CITY OF MESQUITE, DALLAS COUNTY, TEXAS AS RECORDED IN VOLUME 73016, PAGE 789 OF THE MAP RECORDS OF DALLAS COUNTY, TEXAS; DECLARING AN EMERGENCY: AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, Eastfield Plaza right-of-way from I.H. 30 to Eastfield Boulevard and Eastfield Boulevard from Eastfield Plaza to I.H. 30 is not needed for public purposes and it is the public interest of the City of Mesquite to abandon said described right-of-way; and the staff recommends the abandonment of the right-of-way provided that a drainage and utility easement is retained as described in Exhibit "A";

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESOUITE, TEXAS:

SECTION_1. That a portion of Eastfield Plaza right-of-way from I.H. 30 to Eastfield Boulevard and Eastfield Boulevard from Eastfield Plaza to I.H. 30 more particularly described in Exhibit "A" attached hereto and included herein for all purposes shall be, and the same is hereby abandoned.

That the orderly development of the City of Mesquite requires the SECTION 2. release and abandonment of a portion of Eastfield Boulevard described herein creates an urgency and emergency in the public interest and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of the caption as the law in such cases provides.


