ORDINANCE NO. 3110

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9 OF THE CODE OF THE CITY OF MESQUITE BY DELETING AND ADDING LANGUAGE TO SECTION 9-147 SUBSECTIONS (1) AND (5); PROVIDING THE LOCATION AND TIME OF SAID SCHOOL ZONES AND ESTABLISHING THE MAXIMUM PRIMA FACIE SPEED LIMIT DURING SUCH PERIOD TO BE TWENTY (20) MILES PER HOUR; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Section 9-147 subsections (1) and (5) of the Code of the City of Mesquite are hereby amended as follows, in all other respects to remain in full force and effect:

The following language shall be deleted from Section 9-147 subsection (1) and (5) of the Code of the City of Mesquite:

> (1) School zone times for the following locations are from 7:00 a.m. to 8:15 a.m. and from 2:30 p.m. to 3:30 p.m.:

LaPrada Drive from Ivy Drive to 300 feet west of Sandra Lynn Drive

(5) School zone times for the following location are from 7:00 a.m. to 8:15 a.m. and from 1:30 p.m. to 3:30 p.m.:

Galloway Avenue from 300 feet north of Hillcrest Street to 300 feet south of Hillcrest Street

Crestridge Street from 150 feet west of Northridge

Drive to Galloway Avenue

Northridge Drive from 150 feet south of Hillcrest Street to 150 feet north of Crestridge Street

Hillcrest Street from Galloway Avenue to 150 feet west of Northridge Drive

B. The following language is to be added to Section 9-147. Same-School zones, subsection (3) of the Code of the City of Mesquite:

(3) School zone times for the following locations are from 7:00 a.m. to 8:15 a.m. and from 2:30 to 4:00 p.m.:

Crossing to 250 feet southeast of Creek Crossing

SECTION 2. That should any paragraph, sentence, subdivision, clause, phrase, section or provision of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision hereof other than the part so decided to be unconstitutional, illegal, or invalid and shall not affect the validity of the remainder of Section 9-147, or any other provision of the Code of the City of Mesquite.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 4. The fact that the present ordinances of the City of Mesquite do not adequately protect the safety of the inhabitants of the City, creates an urgency and emergency and in the preservation of the public health, safety and welfare requires that this

ordinance shall become effective immediately from and after its passage and the publication of caption, as the law in such cases provides.
