ORDINANCE NO. 3202

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ABANDONING A CERTAIN SIGN EASEMENT LOCATED IN THE CREEK CROSSING AREA AT THE INTERSECTION OF NEWSOM ROAD AND CREEK VALLEY ROAD; PROVIDING A SEVERABILITY CLAUSE AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

<u>SECTION 1.</u> That the sign easement located at the southeast corner of the intersection of Newsom Road and Creek Valley Road described in Exhibit "A" attached hereto shall be and the same is hereby abandoned.

<u>SECTION 2.</u> That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

<u>SECTION 3.</u> That the present ordinances of the City of Mesquite are inadequate to insure the orderly development of the City of Mesquite creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that the easement described herein be abandoned, and that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
